### Oil and Gas Properties

#### Bougie Trutch Area

The company has a participation agreement with Tenaka Drilling Consortium Ltd., wherein it was granted the right to 15% working interest in 26 sections (26 square miles). It has also earned its working interest. It has 14 Halfway sections with an additional 6 Halfway sections. The company also has a 24% working interest in 14 sections of deep rights.

As of January 31, 2009, the company drilled six wells on the Bougie Trutch property, including three producing Triassic Halfway wells, the C-36-A/94-G-15, B-56-A/94-G-15, and A-38-A/94-G-15.

#### The Trutch East Property

The Trutch East is located in the prolific natural gas producing Western Canadian Sedimentary Basin in north-eastern British Columbia on trend with the East to West industry expansion of pipeline and support infrastructure. The Trutch East lands consist of 2 sections (district spacing units), which hold the potential for a total of approximately 4 Triassic Halfway development wells (upon half-spacing drilling targets). The property adjoins the company's Bougie Trutch lands. It retains the right of first refusal on two additional sections on the property.

As of January 31, 2009, the company drilled one Triassic Halfway well on the Trutch East property. Its interest in total production was 8,712 MCF, equivalent daily rate of 25.18 MCF/day for the year ended January 31, 2009.

### Prophet River

The company owns a 33.33% of the Prophet River property, which included 19 square mile surface to basement and 2 square miles base of debolt to basement.

### Mineral Properties

#### Thrust Project

The company has an option agreement to acquire a 100% interest in the Polymetallic Thrust project located in North Eastern British Columbia.

### History

The company was founded in 1984. It was formerly known as Wyn Developments Inc. and changed its name to Canada Gas Corp. in 2008.

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

### **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
