Oil and Gas in the Netherlands

SUMMARY

Oil & Gas in the Netherlands industry profile provides top-line qualitative and quantitative summary information including: market size (value 2015-19, and forecast to 2024). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The oil and gas market volume is defined as the total consumption (barrels of oil equivalent) of refined petroleum products and natural gas by end-users in each country.

The Dutch oil and gas market had total revenues of \$20.9bn in 2019, representing a compound annual growth rate (CAGR) of 3.6% between 2015 and 2019.

Market consumption volumes declined with a compound annual rate of change (CARC) of -1.4% between 2015 and 2019, to reach a total of 507.6 million BoE in 2019.

Although demand for gasoline increased by 2% in 2019, as a result of lower prices, demand for jet oil and bunker oil by the airline and maritime industry, respectively, as well as demand for naphtha by the petrochemical industry, was significantly reduced at almost double-digit rates.
