The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The spirits industry within the NAFTA countries had a total market value of \$1,58,750.1 million in 2023. The Canada was the fastest growing country, with a CAGR of 6.4% over the 2019-23 period.

Within the spirits industry, the US is the leading country among the NAFTA bloc, with market revenues of \$1,33,308.1 million in 2023. This was followed by Canada and Mexico, with a value of \$16,132.0 and \$9,310.0 million, respectively.

The US is expected to lead the spirits industry in the NAFTA bloc, with a value of \$2,03,148.9 million in 2028, followed by Canada and Mexico with expected values of \$25,536.3 and \$23,898.4 million, respectively.
