UHD TV (also known as Ultra High Definition TV Super Hi-Vision, Ultra HD television, Ultra HD, UHDTV, or UHD) includes 4K UHD (2160p) and 8K UHD (4320p) which are two digital video format that have 3840 ? 2160 (4 K) or 7680 ? 4320 (8 K) pixel resolutions, and they are 4 or 16 times larger than 1920 ? 1080 (2K) pixel resolution of the standard full HDTV, respectively.
