In 2015, global air transport industry was benefit from low oil prices and positive economic tendency, the revenue of air passenger transportation was USD525 billion, freight transport revenue has reached USD52 billion. By estimated, global air transport passenger capacity will raise to 3.8 billion people and 54 thousand airlines.

Based on the statistics, global aviation industry gross profit reached USD33 billion with 6% YoY growth; however, industrial profitability rate was only about 5%, which indicated airline companies average profit gained from every single customer was less than 10 cents. According to International Air Transport Association, the estimate profit of global aviation industry make will reach USD36 billion in 2016.

There are 13 listed companies in air transport industry in China; the 13 listed companies have been made over RMB400 billion in revenue, and the total asset has reached over RMB831 billion. Air China Company is the one with the largest total asset, and China Southern Airlines has made most revenue among 13 listed companies.
