1. INTRODUCTION

Comprehensive sector companies operate wide range of business; the business performance of the companies in such sector is significant influence by national economy environment. In 2015, China's annual GDP has reached RMB67 trillion, which is 6.9% YoY growth. The national economy development of China was stable steady growing continuously; above scale industrial companies exported volume reached RMB11 trillion with 18% drop compare to preceding year; annual output-sale ratio achieved 97.6%. The fixed assets investment was about RMB55 trillion, which is actual 2.9% drop of growth speed. On the other hand, Internet technologies and online concepts have wide merged into consumption market, the value of online sales in 2015 was over RMB3 trillion with 33.3% YoY growth. Thereinto RMB3.2 trillion of physical good sold which account for over 10% of the aggregate social retail sales; and the value of non-physical good sold was about RMB630 billion in 2015.

There are 25 listed companies in comprehensive sector industry in China; the 25 listed companies have made over RMB34 billion in revenue and the total assets have reached over RMB127 billion. Shanghai Zhangjiang Hi-Tech Park Development Company is the one with the largest total asset, and MeiDu Energy Corporation has made most revenue among 25 listed companies in 2015.
