1. INTRODUCTION

Fishery industry of China developed behind the leading countries, however, it is growing dramatically fast during past decades. Chinese government invested in fishery, as well as made the supporting policies. At present, fishery industry is one of the leading industries in China.

Fishery is a very important part of modern agriculture and marine economy. Since “reform and opening up”, fishery industry was in high speed developing, the output risen from RMB328.7 billion to RMB460 billion through 2011-2015, which CAGR exceeds 8%. For Chinese fishery industry structure, some provinces have been reversed overfishing situation, which aquaculture output surpassed consumption in 2015.

There are 10 listed companies in fishery industry in China; the 10 listed companies have been made over RMB11 billion in revenue, and the total market capitalization has reached over RMB25 billion. Shandong Homey Aquatic Development Company is the one with the largest market capitalization, and Dalian Zhangzidao Fishery Group Company has made most revenue among 10 listed companies.
