Actelion's first product Tracleer (bosentan), a dual endothelin receptor antagonist (ERA), is an oral treatment for pulmonary arterial hypertension (PAH), a chronic, lifethreatening disorder which is characterized by abnormally high blood pressure in the arteries between the heart and lungs. Tracleer works by blocking the detrimental affects of endothelin, a substance secreted by the endothelium, a single layer of cells covering the inner surface of blood vessels.

Actelion markets Tracleer through its own subsidiaries in key markets worldwide, including the United States, the European Union as well as Canada, Israel, Australia and Switzerland.



#### Zavesca

Zavesca provides a novel approach to the treatment of Gaucher's disease by inhibiting the formation of glucosylceramide, an important element in the formation of these lipids. An added advantage of Zavesca is that it is an oral treatment and therefore may be more suitable for those patients who are unable to receive enzyme replacement therapy.

Zavesca is indicated for the oral treatment of mild to moderate type 1 Gaucher disease, when enzyme replacement therapy is unsuitable.

#### Collaborations

Actelion, Ltd. and Roche Holding AG have entered into a collaboration to jointly develop and commercialize Actelion's selective S1P1 receptor agonist, an immunomodulator with the potential for once-a-day oral dosing. The compound is being developed in Phase I. The two companies intend to jointly develop and commercialize this compound for multiple autoimmune disorders. The S1P1 collaboration covers both the selective S1P1 receptor agonist in Phase I as well as any other selective S1P1 receptor agonists resulting from Actelion's research efforts in the field.

The company and GlaxoSmithKline plc have entered into a worldwide collaboration (excluding Japan) for Actelion's almorexant, an orexin receptor antagonist in phase III development with first-in-class potential as a treatment for primary insomnia.

# **ANALYSIS FEATURES**

#### **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

#### **Enhanced SWOT Analysis**

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

## IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

#### **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

#### **VRIO** Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
