The Edwards Group manufactures grain aeration systems and related equipment. The Edwards division also includes the Twister product line, including grain storage bins, bin unload systems, and aeration equipment.

Hi Roller produces enclosed belt conveyors in Sioux Falls, South Dakota for the commercial and large-farm market.

Twister is a manufacturer of corrugated steel bins in flat and hopper bottom configurations. Twister, along with Edwards Group (another division of Ag Growth International), operates manufacturing facilities in Lethbridge and Nobleford, Alberta.

Union Iron manufactures several lines of material handling and storage equipment in Decatur, Illinois for the commercial and large-farm market.

Applegate manufactures livestock gates, panels, feeders and stock tanks at locations in Indiana and Iowa.

## Products

**Augers:** Augers are used to move grain during seeding, harvesting and conditioning, and at the time grain is shipped to market.

**Enclosed Belt Conveyors:** Enclosed Belt Conveyors are designed for installation in grain handling facilities, corn and soy processing facilities, and industrial operations.

**Belt Conveyors:** Belt Conveyors are used as an alternative to augers, particularly for gentle handling applications.

**Bucket Elevators Drag Conveyors:** Bucket Elevators Drag Conveyors are designed for installation in grain handling facilities, corn and soy processing facilities, and industrial operations.

**Temporary Grain Storage:** This is a re-locatable bulk grain storage system, consisting of modular perforated panels. Typically used for short term storage of grain (less than one year) at commercial handling facilities.

**Permanent grain storage:** This includes corrugated flat bottom and hopper bottom grain storage bins.

**Fencing Equipment:** Line of fencing equipment includes post hole augers and fence post drivers.

**Livestock feeding and containment:** This includes livestock gates and corral panels, hay feeders, bunk feeders, stock tanks and misc.

**Aeration Equipment:** Aeration Equipment is used for grain storage management, aeration and conditioning of grain while in the bin.

**Other Equipment and Parts:** Includes replacement parts and grain handling accessories.
