The US Consumer segment includes the Domain, Northland and Marvel brands and operates mainly in North America. The UK & European Foodservice segment includes the Falcon, Millers Vanguard, Mono and Williams brands operating mainly in the U.K. and Bongard and Pavailler operating in Europe. US Foodservice includes the Adamatic, Belshaw and Victory brands operating mainly in North America.

### **Trading Subsidiaries**

The Company's consumer products business is conducted under trade and business names of AFE Divertimenti, AFE Online, Aga, Fired Earth, Leisure Sinks, and Rangemaster.

The Company's foodservice equipment business is conducted under trade and business names of AFE Serviceline, Falcon Foodservice Equipment, Millers Vanguard, Mono Equipment, and Williams Refrigeration.

The Company's principal consumer overseas businesses include Domain, Inc (USA), Grange SA (France) (75%), Heartland (Canada), La Cornue SA (France), Northland Corporation (USA) and Waterford Stanley Limited (EIRE).

The Company's principal foodservice overseas businesses include Adamatic, A Corporation (USA), Belshaw Bros., Inc (USA), Bongard SA (France), Ming Fai Stainless Steel Catering Equipment, Manufacturing Co. Limited (Hong Kong), Pavaille Holding SAS (France), Victory Refrigeration LLC (USA), and Williams Refrigeration Limited (Australia).

The Company's Central Services is conducted through AFG Corporate Services Limited, and AFG Properties Limited.

The Company's other principal foodservice business is conducted through Williams Refrigeration Central Limited (80%).

## Acquisitions

The acquisitions made and increased interests during 2005 were:

June 2005 – acquisition of Waterford Stanley, an Irish range cooker and stove manufacturer; July 2005 – increased share ownership of Grange, a French furniture manufacturer, from 40.7% to 75.0%; August 2005 – acquisition of Divertimenti Retail, a U.K. kitchenware retailer; and November 2005 – acquisition of Heartland Appliances, a Canadian range cooker manufacturer.

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

## **VRIO Analysis**

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Organizational

Intangible resources
