The company operates its business in two segments, Specialty Pharmaceuticals and Medical Devices.

SPECIALTY PHARMACEUTICALS SEGMENT

The Specialty Pharmaceuticals segment produces a range of pharmaceutical products, including ophthalmic products for chronic dry eye, glaucoma therapy, ocular inflammation, infection, allergy and retinal diseases; Botox for certain therapeutic and



aesthetic indications; skin care products for acne, psoriasis, other prescription and overthe-counter skin care products and eyelash growth products; and urologics products.

Eye Care Pharmaceuticals Product Line

The company develops, manufactures, and markets a range of prescription and non-prescription products designed to treat diseases and disorders of the eye, including chronic dry eye, glaucoma, inflammation, infection, and allergy.

Chronic Dry Eye: Restasis (cyclosporine ophthalmic emulsion) 0.05%, or Restasis, is the prescription therapy for the treatment of chronic dry eye worldwide. Restasis is approved in 34 countries.

Artificial Tears: The company's artificial tears products, including the Refresh and Refresh Optive brands, treat dry eye symptoms, including irritation and dryness due to pollution, computer use, aging, and other causes. Refresh is the over-the-counter artificial tears brand in the United States and includes a range of preserved and non-preserved drops, as well as ointments to treat dry eye symptoms.

Glaucoma: The company's products for the treatment of glaucoma include Lumigan (bimatoprost ophthalmic solution) 0.03% (Lumigan 0.03%), Lumigan 0.01%, Alphagan (brimonidine tartrate ophthalmic solution) 0.2% (Alphagan), Alphagan P 0.15%, Alphagan P 0.1%, Combigan (brimonidine tartrate/timolol maleate ophthalmic solution) 0.2%/0.5%, or Combigan, and Ganfort (bimatoprost/timolol maleate ophthalmic solution) (Ganfort). Lumigan 0.03% and Lumigan 0.01% are topical treatments indicated for the reduction of elevated intraocular pressure in patients with glaucoma or ocular hypertension. Lumigan 0.01% is an improved reformulation of Lumigan 0.03% for sale in certain countries outside of the United States. The company sells Lumigan 0.01% and Lumigan 0.03% in approximately 75 countries worldwide. Ganfort is sold in approximately 29 countries outside the United States.

The company's ophthalmic solutions include Alphagan, Alphagan P 0.15%, and Alphagan P 0.1%. These products lower intraocular pressure by reducing aqueous humor production and increasing uveoscleral outflow. Alphagan P 0.15% and Alphagan P 0.1% are improved reformulations of Alphagan containing brimonidine, the active ingredient in Alphagan, preserved with Purite. The company markets Alphagan, Alphagan P 0.15% and Alphagan P 0.1% in approximately 70 countries worldwide. In addition to its Alphagan and Lumigan products, the company has developed the ophthalmic solution Combigan, a brimonidine and timolol combination designed to treat



glaucoma and ocular hypertension in people who are not responsive to treatment with one medication and are considered appropriate candidates for combination therapy.

Inflammation: The company's ophthalmic anti-inflammatory product is Acular LS (ketorolac ophthalmic solution) 0.4% (Acular LS). Acular LS is a version of Acular that has been reformulated for the reduction of ocular pain, burning, and stinging following corneal refractive surgery. Acular PF is indicated for the reduction of ocular pain and photophobia following incisional refractive surgery.

ANALYSIS FEATURES

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Tangible resources

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity



Reputation

Organizational capabilities
