The company also has overseas operations. It is in the process of acquiring investments in five concessionaires that operate a total of 702 km of toll motorway in Brazil and Chile. There are 255 service areas along the motorway network operated by the company and its motorway subsidiaries.

#### Traffic

The total number of kilometres travelled on the networks managed by the company during 2008 amounted to 55,078 million: 42,619 million by light vehicles and 12,459 million by heavy vehicles.

# **Motorway Subsidiaries**

In addition to Autostrade per l'Italia's investments in major works, Autostrade Meridionali, Raccordo Autostradale Valle d'Aosta and Strada dei Parchi are engaged in



works on 52 km of motorways.

International activities

Stalexport Autostrady: Stalexport Autostrady, a Polish-registered company, holds the motorway concession for the 61 km long A4 Krakow-Katowice motorway via its wholly owned subsidiary, Stalexport Autostrada Malopolska. During 2008, the section of motorway managed by the concessionaire, Stalexport Autostrada Malopolska, registered an average daily traffic volume of 28,670 vehicles (including both light and heavy components), representing a total of approximately 640 million km travelled.

Electronic Transaction Consultants (ETC): ETC is a U.S. provider of systems integration, hardware and software maintenance, customer services and consultancy in the field of free flow electronic toll collection systems.

Pune-Solapur concession in India: In February 2009, Atlantia, in consortium (50-50) with Navinya Buildcon Private Limited (NBPL), a wholly owned subsidiary of the Tata Group, was awarded the concession for the 110-km Pune-Solapur section of motorway in the Indian state of Maharashtra.

#### **SWOT Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

# IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

#### **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

#### **VRIO** Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
