Confederation Lake

The Confederation Lake properties (8 claim groups) are base metal and gold prospects situated in the Red Lake Mining Division, Northwestern Ontario.

The company has an option agreement to acquire from Xstrata Canada Corporation, a 100% interest in a group of mineral properties collectively known as the Confederation Lake properties.

McFaulds Lake

The company has an agreement with Goldeye Explorations Limited (Goldeye) to form a joint venture related to a group of properties within the area known as The Ring of Fire located in the Lower James Bay region of Ontario, in the proximity of McFaulds Lake (the Property). At the time of the agreement, Goldeye had 15 claims, totaling 216 claim



units, covering 3,456 hectares in the McFaulds Lake area. The McFaulds Lake joint venture holds approximately 27,000 hectares.

In November 2009, the company has completed additional staking around its South Bend Property which is part of its 'Ring of Fire' property package of the James Bay Lowlands. An approximate total of 12,200 hectares of approximately 54 claims have been added in the vicinity of Tribute's Sunday Anomaly VTEM targets. The South Bend Property is located 30 kilometers east southeast of the First Nation community of Webequie and 40 kilometers west of Noront's Eagle Nest Ni-Cu-PGE Deposit.

In April 2009, the company signed a letter of intent with Goldeye to acquire the 50% interest in the McFaulds Lake joint venture.

Other properties

Other properties include the Richardson Lake property, the Bridget Lake property, the Fredart Lake property, the Woman River property, and the Clay South Property, all of which are in Northern Ontario.

The company has an option agreement with Halo Resources Ltd. for the right and option for Halo to earn approximately 75% interest in the Bridget Lake property.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
