As of June 30, 2009, the company had 73 local access customers in 283 communities with an aggregate total of 733 active connections.

Segments

The company designs, constructs and operates OAN NextGens in Alberta, France, and Singapore which comprise the North American, European, and Asian business segments respectively. All of the activities for the European segment are conducted pursuant to a joint venture.

Alberta Business: The Alberta SuperNet

The Alberta SuperNet is a community interconnect grid connecting 429 communities in Alberta. The company sells Real Broadband services directly to approximately 4,400 government, learning, health, library, and municipal locations and to local access customers in communities in rural Alberta.

France Business: Covage

The company, in 2006, formed Covage, a French company jointly owned by Axia Networks France, a wholly owned subsidiary of Axia, and French partner, VINCI Networks (VINCI), a wholly owned subsidiary of VINCI Construction France. Covage sells NGN Transport Services. Covage's OAN business is comprised of 15 segments. Covage would light, operate, and sell Real Broadband services on this segment pursuant to a ten-year renewable contract. As of June 30, 2009, Covage had 44 retail service providers with 659 broadband connections that consist of 334 bandwidth connections and 325 dark fibre connections.

Singapore Business: OpenNet

The company, as of June 30, 2009, commenced operations in Singapore. The company, in September 2008, announced that OpenNet had been selected by the Infocomm Development Authority of Singapore (IDA) to provide passive fibre services to every premise in Singapore. The company was the OpenNet Consortium lead through the procurement and contract award process and owns a 30 percent interest of OpenNet through a wholly owned Singapore subsidiary, Axia NGNetworks Asia.

History

Axia NetMedia Corporation was founded in 1994.
