Segments

The company operates in four segments: Coal Reclamation (Coal), Carbon Dioxide (CO₂), e-Commerce (e-Commerce), and Oil and Gas (Oil & Gas).

COAL RECLAMATION ACTIVITIES

The coal reclamation (Coal) segment operates coal fines reclamation facilities in the U.S. The coal reclamation activities are conducted by Beard Technologies, Inc. (BTI). BTI operates coal fines reclamation facilities in the U.S. and provides slurry pond core drilling services, fine coal laboratory analytical services, and consulting services.

CARBON DIOXIDE OPERATIONS

The CO₂ segment produces CO₂ gas. The CO₂ gas operations are conducted by the parent company which owns working and overriding interests in two CO₂ gas producing units. The company owns non-operated working and overriding interests in two producing CO₂ gas units in Colorado and New Mexico.

Carbon Dioxide (CO₂) Properties

McElmo Dome: The McElmo Dome field in Dolores and Montezuma Counties in western Colorado is approximately 240,000-acre unit which produces CO₂ gas.

Kinder Morgan CO₂ Company, L.P. (KM) serves as operator of the unit. There are 54 producing wells, ranging from approximately 7,634 feet to 8,026 feet in depth that produce from the Leadville formation.

Competition: The company's competitors for CO₂ include suppliers that have an ownership interest in McElmo Dome, Bravo Dome and Sheep Mountain CO₂ reserves, and Petro-Source Carbon Company, which gathers waste CO₂ from natural gas production in the Val Verde Basin of West Texas.

Productive Wells: As of December 31, 2008, the company held a working interest in approximately 46 gross (0.248 net) CO₂ wells located in the McElmo Dome Unit in Colorado.

e-COMMERCE

The e-Commerce (e-Commerce) segment develops business opportunities through starpay's intellectual property portfolio of Internet payment methods and security technologies. The e-Commerce activities are conducted by starpay.com, l.l.c. (starpay) and its parent, Advanced Internet Technologies, L.L.C. (AIT).

The company's secure payment methods and technologies address payer and transaction authentication. These include performing a payer query for authentication and transaction consent verification, as well as, chaining split transactions into an integrated verifiable transaction authenticating the user and the transaction attributes in the process.

OIL AND GAS OPERATIONS

The Oil & Gas segment produces oil and gas. The activities of the Oil and Gas Segment are conducted through the company's wholly-owned subsidiary, BOC. BOC is engaged in exploration for, development, production, and sale of oil and gas. The oil and gas operations engage in the production of oil and gas. It owns non-operated working interests or overriding interests in producing wells in Colorado and Wyoming. It also owns undeveloped oil and gas leases in such states and in Mississippi.

Sandy Lake Field: The company owns a 640-acre tract in Yuma County, Colorado.

Big Porcupine Field: BOC also has a 4.5% overriding royalty interest in 12 wells which produce coal bed methane gas from the Mesaverde Formation from a 317-acre tract in Section 1, Township 41 North, Range 71 West, Campbell County, Wyoming. The wells were drilled by Peabody Natural Gas, LLC on a lease BOC sold to them in 2000 on which BOC retained an overriding royalty interest.

History

The Beard Company was founded in 1921.
