Bezeq International, Ltd.: The company owns 100% of Bezeq International, Ltd. It manages the group's international telecommunications network. The company provides Internet service in Israel. The company owns 37% of Walla, an Israeli Internet portal.

BezeqCall Communications, Ltd.: The company owns 100% of BezeqCall Communications, Ltd. It engages in the installation and provision of infrastructure and services for private networks.

Bezeq On-Line, Ltd.: The company owns 100% of Bezeq On-Line, Ltd. It provides call-center services.

Goldnet Communications Services, Ltd.: The company owns 75% of Goldnet Communications Services, Ltd. It is a partnership of Bezeq and Maalam providing e-commerce solutions to businesses and value-added services, such as Internet, e-mail, EDI, databases, and fax transmissions.

YES: The company owns 49% of YES. It is a joint venture between Bezeq, Eurocom and others, which provides multi channel TV services.

Services

Telephone Line Services

The company offers its telephone line services through its subsidiary Bezeq, The Israel Telecommunication Corp., Ltd. The company's telephone line services include: Bezeq Stars Services, such as repeat call services, last call services, call waiting cancellation services, call forward services, and speed dial services; online services, such as voice mail, caller id, call waiting, call waiting with caller id, conference call, lead number, multiline, ISDN, telecampus, and collect call; information services, such as wake-up call service, talking clock service, vocal information service, and pager services; and calling card services, such as Telecard services and BezeqCard services.

International communication and Internet services

The company offers its international communications and Internet services through its subsidiary Bezeq International Ltd. Internet services provided by the company include: WOW High Speed Internet, ClickTalk, Click Talk/Click BackInternet Call Waiting, and



Mamtinet.

Customer Service

The company's customer services include 199 via e-mail, Full Time, Direct Bank Debit, Service Treaty, and Cellular Changes.

Business Account Service

The company's business account service makes it possible to accumulate all Bezeq invoices that are due on the same date, including: telephone line invoices, Bezeqcard, information transmission lines (Isranet, Frame Relay, etc.).

Data Communications Services

The company's data communications services include ATM services; Frame Relay, which transfers data between computers and between networks; Super Frame Relay, which enables temporary and access of remote branches and offices to central sites; Isranet, which is a public communication network for switching dose technology data transmission; Avnet network, which secures the phone lines- the orderliness of the phone line; Sifranet, which enables secured and controlled digital data communication; Business Access, which enables remote-users to connect to the LAN at main business site; and Speedy Credit Transaction, which enables a permanent connection (online with no dial-up) between the business and Sheba, for speedy approval of credit transactions.

Telephony Services

The company's telephony services include: Lead Number, Forwarding Area Code, 1-700, Call Divert on a Busy Line, Freephone 1-800, PRI, and MultiLine.

ANALYSIS FEATURES

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Innovation and Creativity

Organizational capabilities
