Biolase Technology, Inc., a medical technology company, engages in the development, manufacture, and marketing of lasers, related products, and services focused on technologies for applications and procedures in dentistry and medicine.

#### **Products**

The company's Waterlase Dentistry solution is a group of products, including dental laser systems that allow general dentists, periodontists, endodontists, oral surgeons, and other specialists to perform a range of dental procedures, including cosmetic and surgical applications. The Waterlase Dentistry solution offers two categories of laser system products: its Waterlase family of products and its Diode family of products which includes its ezlase and iLase systems, as well as related consumables, training and services. In addition to products developed for the dental market, in 2009, the company introduced its first product outside of its primary market, the Diolase 10, as part of its expansion into the medical specialty markets, including sports medicine, orthopedics, physical therapy, and chiropractics. The Diolase 10 is a diode laser used for therapeutic applications, including temporary pain relief and is based on the ezlase platform.



Waterlase systems: The company's Waterlase systems use a patented combination of water and laser to perform various dental procedures performed using dental drills, scalpels and other traditional dental instruments for cutting soft and hard tissue plus bone. The company's Waterlase systems consist of the Waterlase MD and Waterlase C100 All-Tissue Dental Laser systems. Each of these systems is designed around its patented YSGG Laser HydroPhotonics technology. HydroPhotonics refers to the interaction of laser with water to produce energy to cut tissue. Through YSGG Laser HydroPhotonics, the Waterlase systems can cut hard tissue, such as bone and teeth, and soft tissue, such as gums, without the heat, vibration or pressure associated with traditional dental treatments. In 2009, the company introduced the Waterlase MD Turbo All-Tissue Dental Laser System.

Diode systems: The company also offers a line of Diode laser systems which use a semiconductor diode laser to perform soft tissue, cosmetic procedures and teeth whitening in dentistry and for pain management therapy. Its Diode laser systems consists of the ezlase and iLase, semiconductor diode lasers to perform soft tissue, hygiene, and cosmetic procedures, including teeth whitening. The company's ezlase system serves the markets of general, cosmetic, orthodontic, and hygiene procedures. It features a new pulse mode, ComfortPulse, which allows the tissue to cool between pulses resulting in improved patient comfort. Other features include wireless foot pedal control, disposable single-use tips, color touch screen activation with approximately 15 procedure based pre-sets, whitening hand piece, rechargeable battery pack and wall mount. The company received clearance for tooth whitening using the ezlase system. In February 2010, the company introduced its new iLase diode laser system, a dental diode laser that provides solutions for the everyday soft tissue surgical and hygiene procedures.

The company sells its products in approximately 50 countries. The company's systems have the CE Mark and may be sold in the European Union. Additionally, it has approval to sell its laser systems in Canada, Australia, New Zealand, and other Pacific Rim countries.

#### Related Accessories and Disposable Products

The company also manufactures and sells disposable products and accessories for its laser systems. Its Waterlase and ezlase systems use disposable laser tips of differing sizes and shapes depending on the procedures being performed. The company also markets flexible fibers and hand pieces that the dental practitioner would replace at some point after initial purchase of the laser system. For its ezlase system, the company manufactures and sells tooth whitening gel kits.



#### Marketing and Sales

The company markets its laser systems in the United States and worldwide. It markets its laser systems to dental practitioners; chiropractors; physical therapists; and other pain management specialists. It also markets laser systems directly to patients. The company has entered into an agreement with Henry Schein, Inc. to distribute its products in certain international countries, including Germany, Spain, Australia, and New Zealand.

#### Competition

The company's Waterlase systems primarily compete with laser systems manufactured by Hoya ConBio, a subsidiary of Hoya Photonics; Lares Research, the U.S. distributor of Fotona, a European company; and Syneron, an Israeli based company. In the international market, its Waterlase systems compete primarily with products manufactured by various additional companies, including Fotona d.d., KaVo, and Deka Dental Corporation. It also competes with OpusDent Ltd., a subsidiary of Lumenis.

The company's Diode systems, including ezlase and iLase, compete with other semiconductor diode lasers manufactured by Ivoclar Vivadent AG, Sirona, KaVo Hoya, AMD, and Discus Dental.

#### History

The company was founded in 1984. It was formerly known as Societe Endo Technic, SA and changed its name to Biolase Technology, Inc. in 1994.

### **ANALYSIS FEATURES**

#### **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

#### **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



### Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

#### IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

#### **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
