# **Organic Compound Fertilizers**

Organic compound fertilizers are the company's primary products. Organic fertilizers comprise natural nutritional elements. Organic compound fertilizer improves reproduction of soil microbes to improve soil quality through the decomposition of organic material and the improvement of the soil's retention of nitrogen. The company's organic fertilizer line includes compound organic fertilizers containing organic matter content levels of 20%, 25%, 35%, and 45%. Each of these organic compound fertilizers can then be further narrowed into the following product types: wide field, fruit, vegetable, melon, or pepper. The company also produces various Bulk Blend (BB) organic fertilizers, which contain organic matter content levels of 35%, 40%, and 54%. In



addition, the company produces various solid organic fertilizers.

# Liquid Fertilizers

The company's liquid fertilizer line includes the following products: 'New Guo Li Dan (500G and 250G)', 'New Shi Kang Lu (500G)', 'New Jia An Gai', 'An Fu Lv Ye Wang', 'Tian Feng', and 'Feng Chan Su (20KG)'. Liquid fertilizer is sold to farmers in a concentrated form and needs to be mixed with water before it is sprayed onto plants.

### Pesticides and Insecticides

The company's pesticide products applied to fruit trees and vegetable crops, and are used to kill various insects and pests that reduce crop yield. Its insecticide products are applied to various fruit trees, vegetables, and other crops to kill bacteria and to prevent the reproduction of harmful insects and pests. The company's pesticides and insecticides include the following products: 'Wei Te Li Oil',' A Wei Chai Oil', 'Lun Mei Su', 'Li Jun Sha', 'Jin Li Sheng', and 'Lun Mei Qing'.

# Sales and Marketing

# **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

# **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



# Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

# IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

# **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
