Products and Services

The company's products include GlucoTel, PressureTel and WeightTel.

GlucoTel System

GlucoTel System is a blood glucose monitoring system designed for diabetic patients. The transmission from the GlucoTel meter to the patient's mobile phone is performed through Bluetooth technology. The transmission from the patient's mobile phone to the company's Internet database is performed by the mobile phone Internet connection. In addition to blood glucose measurements, the system also allows the patient to record other events like exercise and food intake which would also be wirelessly transmitted and stored on the internet database.

GlucoTel Kit



GlucoTel kit is packaged in a travel case with room for the lancing device, lancets, the GlucoTel blood glucose test strips and the GlucoTel blood glucose meter. With the GlucoTel and its built-in Bluetooth module, measured values are transmitted from the GlucoTel meter through the patient's Bluetooth enabled mobile phone to the company's database.

BodyTel Mobile (Java application)

BodyTel Mobile is a Java application downloaded directly onto the patient's mobile phone. After installation, the patient is required to synchronize the GlucoTel meter with the patient's mobile phone using Bluetooth to calibrate the GlucoTel meter and transmit test values. The company has designed the PressureTel and WeightTel products to utilize BodyTel's Mobile application. The application is capable of handling data from all three platforms (GlucoTel, PressureTel and WeightTel).

BodyTel Center (Internet Portal)

The BodyTel Center (www.BodyTel.com) is the Internet portal through which patients and caregivers access measurement results. The BodyTel Center allows patients and authorized care givers to view real-time test results, create acceptable test result parameters, and receive notification when results are outside of the acceptable parameters and provides access to historical test results. In addition, the BodyTel Center offers diabetes-related editorial content.

Products in Development

The company engages in the development of PressureTel and WeightTel. PressureTel and WeightTel are telemedical monitoring and management systems for blood pressure and body weight. These systems utilize the company's BodyTel Mobile software and BodyTel Center Internet portal in conjunction with Bluetooth enabled conventional blood pressure and body weight monitoring devices.

Subsidiaries

The company's wholly owned subsidiaries include GlucoTel Scientific, Inc.; BodyTel North America LLC; and BodyTel Europe GmbH.

Competition



The company's major competitors marketing blood glucose monitoring devices include Abbott Laboratories, Bayer, Johnson & Johnson (LifeScan), and Roche Holding.

History

The company was incorporated in 2005 as SellCell.Net and changed its name to BodyTel Scientific, Inc. in 2006.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity



Reputation

Organizational capabilities
