It has also entered into an agreement to acquire a 50% interest in approximately 51,862 hectares in a mineral exploration license in an area contiguous to the Reed Lake claims known as the Snow Lake claims.

**Eyehill Creek Potash Property:** The company has entered into an option agreement to acquire a 100% interest in the Eyehill Creek Potash Property, consisting of 20 metallic and industrial minerals permit applications (the MAIM Applications) located at the Saskatchewan-Alberta border.

**Clone Mineral Claims:** The company has the right to earn an undivided 50% interest in the Clone mineral claims, situated in the Skeena Mining Division of northwestern British Columbia.

**Debut Property:** In 2008, the company acquired a 100% interest in the Debut Gold Property, consisting of 16 claims located near Elko, Nevada. Title to the claims was transferred to its wholly-owned Nevada subsidiary, Canasia Industries Nevada Corp., in October 2008.

**Coal Permits:** The company has coal permits on approximately 244,447 acres located in east central Saskatchewan, Canada.

**Mexican Gold Property:** In June 2009, the company acquired the outstanding shares of Exploraciones Las Joyas S.A. De C.V. (Exploraciones), a private company incorporated in Mexico. The assets of Exploraciones consist of a 100% interest in three mineral claims covering approximately 44,522 hectares located north and northwest of the EL Oro – Tlalpujahuá gold/silver belt in the states of Guanajuato and Michoacán, Mexico.

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

### Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

### **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

### **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

### **VRIO Analysis**
