It develops two different types of products: hyperimmunes, which are concentrated specialty antibody preparations made from plasma; and recombinant biopharmaceuticals, which are therapeutic proteins made by introducing a particular gene into a host organism, which in turn produces the protein of interest. It also provides third-party contract-manufacturing services.

## Product Portfolio/Pipeline

WinRho SDF: The company's primary product, WinRho SDF, is a hyperimmune antibody product specific for a certain type of red blood cell (also known as anti-D). It is indicated treating immune thrombocytopenic purpura (ITP), an autoimmune, platelet disorder, and preventing hemolytic disease of the newborn (HDN). It is approved in Canada, the U.S., and various other countries worldwide.

HepaGam B: HepaGam B is a hyperimmune antibody product specific for hepatitis B



surface antigen. It is indicated for preventing recurrence of hepatitis B virus infection following liver transplantation and treating acute exposure to hepatitis B virus (post-exposure prophylaxis (PEP)). It is approved for both indications in Canada, the United States, and Israel.

VariZIG (Varicella Zoster Immune Globulin (Human)): VariZIG is a niche product serving a percentage of the population that is at-risk and susceptible to chickenpox. It is a hyperimmune antibody product specific for the virus that causes chickenpox (Varicella zoster). It is indicated for the prevention or reduction in severity of maternal infections in pregnant women. It is approved in Canada.

Vaccinia Immune Globulin Intravenous (Human) (VIGIV): (VIG): VIG is a hyperimmune antibody product specific for the virus that is used to make smallpox vaccine. VIG is used to treat or prevent these complications and is considered an important component of smallpox vaccination programs. It is approved in the U.S. and Canada.

Botulism Antitoxin Heptavalent (Botulinum Toxin Immune Globulin): (BAT): BAT is a preparation of antibodies specific for the seven bacterial neurotoxins that cause botulism. BAT is a heptavalent hyperimmune antibody product specific for the toxins that cause botulism. This product is investigational and is in ongoing studies.

Anthrax Immune Globulin (AIG): AIG is a hyperimmune antibody product specific for Bacillus anthracis bacteria. This product is investigational and is in ongoing studies. It is indicated for treating inhalational anthrax.

The company's products also include Ricin immune globulin, which is a hyperimmune: purified antibodies specific for ricin (deadly plant-derived toxin) in preclinical stage; Ebola/Marburg immune globulins, which are monoclonal antibodies to Ebola and Marburg viruses in preclinical stage; Accretropin, a recombinant protein: human growth hormone, a protein that promotes growth of long bones before puberty; Leucotropin, a recombinant protein: granulocyte-macrophage colony-stimulating factor (GM-CSF), a protein that improves mature, infection-fighting white-blood-cell production; and TST10088, a recombinant protein: prodrug based on ricin (deadly plant-derived toxin) in phase I studies.

#### Markets

The company has operations in Manitoba and Ontario in Canada; and in California, Maryland, and Florida in the United States.

In June 2009, the company purchased issued and outstanding shares of privately held Twinstrand Therapeutics Inc., a biotechnology company.

# **ANALYSIS FEATURES**

## **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

## **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

## **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



# Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

## IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

# **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
