About Capex S.A.

Capex S.A. operates as a power generation company in Argentina. The company engages in the exploration and production of petroleum products; generation of electrical energy, including exploration and production of gas; and the production and sale of liquids derived from gas.

The company's main business is in the power sector, where it develops integrated, high-value added projects. Its lines of business include: Power generation and sale; oil, propane, butane and gasoline production and sale; oil and gas exploration and production. The company's Power Plant is in the Agua del Cajón area, province of Neuquén.

Power Plant

The Plant is located in an 11,000 hectare plot of land owned by the company in the Agua del Cajón-Senillosa areas. Facilities have been built on the field, which supplies the gas fed to the plant for power generation purposes.

Open Cycle (Phases I, II and III): These phases, which were developed with a 371 MW installed capacity, involved the installation of six gas turbines.

Combined Cycle (Phase IV): The Combined Cycle mode uses exhaust gases from gas turbines to generate steam in recovery boilers located in each of them. The Agua del Cajón Plant has a total generating capacity of 672 MW.

Power Transformation and Transmission facilities: There is a 132 KV transformer substation adjacent to the Plant, which is connected to the grid via three 132 KV transmission lines, two of which are 29 km long and are connected to the Transener's Arroyito substation. The third is a 50 km long general transmission line connected to the Chocón Oeste substation.

Hydrocarbons production

The major activities carried out by the company include drilling 70 wells, taking 275 km of 2D seismic records and 304 sq km of 3D records, as well as the construction of automated gas extraction and treatment facilities to supply gas to the Power Plant.

History

Capex S.A. was founded in the year 1988.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis
