Segments

The company operates in four reporting segments: the Catlin Syndicate at Lloyd's, Catlin Bermuda, Catlin UK, and Catlin US.

Catlin Syndicate, which comprises direct insurance and reinsurance business underwritten by the Catlin Syndicate at Lloyd's; Catlin Bermuda, which primarily



underwrites reinsurance business, including intra-Group reinsurance; Catlin UK, which primarily underwrites direct insurance; and Catlin US, which primarily underwrites specialty business in the United States through Catlin Insurance Company Inc., which writes on an admitted basis, and Catlin Specialty Insurance Company Inc, which writes non-admitted business.

Catlin Syndicate

The Catlin Syndicate underwrites a variety of business classes, including both direct and reinsurance, property and casualty.

In 2007, the company had three sources of business: Traditional business placed at Lloyd's by wholesale brokers: business underwritten by Catlin's network of international offices. This business is produced by retail brokers and underwritten by local underwriters in the international offices on behalf of the Syndicate; and business written on a coverholder basis by Catlin US.

Catlin Bermuda

Catlin Bermuda primarily underwrites reinsurance coverages, with a particular emphasis on property reinsurance. It also underwrites casualty reinsurance, political risk and terrorism, and structured risk. In 2007, it also began underwriting marine reinsurance.

Catlin UK

Catlin UK (Catlin Insurance Company (UK) Limited) underwrites two categories of business: property and casualty insurance for U.K. commercial clients and specialty classes that are also underwritten by the Catlin Syndicate at Lloyd's.

In 2007, Catlin UK began writing cargo coverages specifically for U.K. clients, in addition to its existing specialties of professional indemnity, general liability, commercial property, commercial crime, and directors' and officers' liability insurance. It also began writing motor coverage for U.K. commercial fleets on 1 January 2008.

Catlin US

Catlin US underwrites various insurance and reinsurance products. The classes of business written by Catlin US include: business that had been written in the United States by Wellington subsidiaries. These classes include accident and health



reinsurance; treaty and facultative property insurance, written on both a brokerage and direct basis; marine reinsurance; specialty casualty insurance coverages; and commercial property, casualty and inland marine insurance written on a binding authority basis by general agents.

Additional classes developed by Catlin US. These classes include professional liability insurance; equine insurance; primary and excess casualty insurance; and crisis management and terrorism insurance.

Markets

The company has operations in Canada, Australia, Singapore, Malaysia, China, Germany, Belgium, Guernsey, France, Spain, Austria, Switzerland, Italy and Brazil.

History

Catlin Group Limited was founded in 1984.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Tangible resources

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity



Reputation

Organizational capabilities
