## **About CBOE Holdings, Inc.**

CBOE Holdings, Inc. intends to operate as the holding company for Chicago Board Options Exchange (CBOE), which operates as an organized marketplace for the trade of standardized, listed options on equity securities. CBOE trades of options on individual equities, market indexes, and exchange-traded funds (ETF).

#### **Products**

The options contracts the CBOE lists for trading include options on individual equities, options on various market indexes and options on ETFs. In addition, the company provides marketplaces for trading futures contracts and cash equities through its CBOE Futures Exchange, LLC (CFE) subsidiary and CBOE Stock Exchange, LLC (CBSX).

Equity Options: The company trades options with terms of approximately 9 months on the stocks of approximately 2,300 corporations. The stocks underlying its individual equity options are listed on the NYSE, NYSE Amex, and NASDAQ. In addition, it also trades long-term options, known as LEAPS, on approximately 800 stocks with terms of approximately 39 months.

Index Options: The company trades options on 10 different broad- and narrow-based



market indexes, including proprietary indexes that it has developed, such as VIX. It also trades index options based on various benchmarks, including VIX, which has become a measure of equity market volatility. Options based on these indexes are among its most actively traded products, with options traded on the CBOE. The company also trades LEAPS on various of its index products.

Options on ETFs: The company trades options on approximately 200 ETFs based on various domestic and foreign market indexes. It also trades LEAPS on 66 ETFs.

Futures: The CBOE provides a marketplace for trading futures through its wholly owned subsidiary, CFE. CFE focuses on the trading of futures related to CBOE-created benchmarks, such as the CBOE volatility indexes and variance benchmarks.

Equities: The CBOE provides a marketplace for individual equity securities through a new trading facility owned with various broker-dealers. This stock exchange, known as CBSX, provides a marketplace for trading stocks on approximately 6,900 companies listed on NYSE, NASDAQ, and AMEX.

## **Proprietary Products**

The CBOE has developed various of its own proprietary indexes and index methodologies. These include volatility and/or variance indexes based on various broad-based market indexes, such as the S&P 500, the Dow Jones Industrial Average (DJIA), the NASDAQ 100, the Russell 2000, realized variance indicators, the CBOE S&P 500 Implied Correlation Index, a number of sector indexes and a series of option strategy benchmarks, including the BuyWrite, the PutWrite and the Collar indexes based on the S&P 500 and on other broad-based market indexes. The company also has licensed others to use some of these indexes to create products and has entered into agreements whereby it has granted to others the rights to sub-license some of these indexes.

### **Business Relationships**

The Options Clearing Corporation (OCC): The company has 20% interest in OCC, which provides clearing and settlement of exchange-traded securities options in the U.S. OCC also clears securities futures for OneChicago and futures for CFE, for the U.S. operations of NYSE Liffe, for the NASDAQ OMX Future Exchange and for the Electronic Liquidity Exchange (ELX).



CBOE Stock Exchange, LLC (CBSX): The company has 49.96% interest in CBSX, which uses CBOE technology to trade approximately 6,900 stocks listed on the NYSE, NASDAQ and the AMEX. CBSX operates an electronic market model utilizing the CBOEdirect trade engine and a price-time matching algorithm. As of December 31, 2009, there were 62 CBSX trading permit holders and 97 CBOE members with trading access to CBSX.

OneChicago, LLC: The company has 23.7% interest in CBOE, LLC, which owns an equity interest in OneChicago, a joint venture originally created with the CME and the CBOT for the trading of securities futures, which are jointly regulated by both the SEC and the CFTC.

NSX Holdings, Inc: The company owns 4.6% equity interest in NSX Holdings, Inc.

CBOE Futures Exchange, LLC (CFE): The company's wholly owned subsidiary, CFE, is regulated by the CFTC. The primary products traded on CFE are futures on various measures of market volatility.

C2 Options Exchange, Incorporated (C2): The company's wholly owned subsidiary, include C2, would operate under a separate exchange license.

CBOE Execution Services, LLC: The company's wholly owned subsidiary, CBOE Execution Services, LLC, is intended to be available for use as a broker-dealer.

The CBOE also has long-term business relationships with various providers of market indexes.

Standard & Poor's Corporation: The company offers contracts on the S&P 500 Index as a result of a licensing arrangement with Standard & Poor's. This license provides the right to use the S&P 500, the S&P 100, and other indexes published by Standard & Poor's as the basis for standardized, exchange-traded options contracts. Under its license with Standard & Poor's, the CBOE has the right to trade options on the S&P 500 Index and S&P 100 Index.

Dow Jones & Co: The company offers contracts on the DJIA as a result of a licensing arrangement with Dow Jones & Co. This license provides it the right to use the DJIA and other indexes published by Dow Jones & Co. as the basis for standardized, exchange-traded options contracts. Under its license with Dow Jones & Co., the CBOE has the right to trade options on the DJIA during standard U.S. trading hours.



NASDAQ: The company offers contracts on the NASDAQ 100 Index as a result of a licensing arrangement with NASDAQ. This license provides the CBOE the right to use the NASDAQ 100 as the basis for standardized, exchange-traded contracts.

Frank Russell Co: The company offers contracts on the Russell 2000 and other indexes in the Russell index family, as a result of a licensing arrangement with Frank Russell Co. This license provides the CBOE the right to use the Russell indexes as the basis for standardized, exchange-traded contracts.

## Competition

The company's primary direct competitors are NYSE Amex, BOX, ISE, NYSE Arca, NASDAQ OMX PHLX, NOM, and BATS.

## **ANALYSIS FEATURES**

## **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

## **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



## Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

## IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
