CECO Environmental Corp. provides solutions to industrial ventilation and air quality problems through dust, mist, and fume control systems and particle and chemical technologies to industrial and commercial customers, primarily in the United States.

Products and Services

The company focuses on engineering, designing, building, and installing systems that capture, clean, and destroy airborne contaminants from industrial facilities, as well as equipment that controls emissions from such facilities. It provides air pollution control products and services through four principal product groups: Contracting/Services Group; Equipment Group; Parts Group; and Engineering Group.

Contracting/Services

The Contracting/Services business unit produces air pollution control and industrial ventilation systems. This business unit comprises the contracting/services operations of its Kirk & Blum divisions. Under the Kirk & Blum trade name the company has four principal lines of business. The primary line, with seven locations throughout the

Midwest and southeast United States, is air pollution control systems and industrial ventilation. These systems, primarily sold on a turnkey basis, include oil mist collection, dust collection, industrial exhaust, chip collection, make-up air, as well as automotive spray booth systems, industrial and process piping, and other industrial sheet metal work. The company provides an engineered solution to in-plant process problems to control airborne pollutants. It has completed major contracts in Mexico and is executing projects in China. It also does projects in Japan, Taiwan, and Korea.

The company provides custom metal fabrication services at its Kirk & Blum Cincinnati, Ohio and Lexington, Kentucky locations. These facilities are used to fabricate parts, subassemblies, and customized products for air pollution and non-air pollution applications from sheet, plate, and structurals and perform the majority of the fabrication for CECO Filters, Busch International, CECOaire, and CECO Abatement.

Equipment

The Equipment business unit produces various types of air pollution control equipment. This business unit comprises CECO Filters, Busch International, CECO Abatement, CECOaire, Effox, GMD, FKI, Flextor, and A.V.C. The company enables its customers to meet BACT requirements and compliance targets for fumes, volatile organic compounds, process, and industrial odors. Its services eliminate toxic emission fumes and volatile organic compounds from large-scale industrial processes. The company has a presence in the chemical processing, ethanol, paint booth emissions, wastewater treatment, and wood products industries.

The company also focuses on the electric power generation market, coal and gas, and the ethanol, metals, and mineral products markets. It provides dampers and expansion joints for flue gas and process air systems with emphasis on steam heat recovery, flue gas desulphurization, and catalytic (NO_x) reduction. For existing systems, Effox provides rebuilding and repair services, including basic design modification. Flextor is quite similar to Effox but its business is international with an emphasis on Latin America.

The company's air pollution control capabilities also include Shaker Dust Collectors, Cupola Emission Control Systems, Flue Gas Coolers, Thermal Sand Reclaimers, and totally enclosed systems for the treatment of heavy metals, acid gases, volatile organic compounds, dioxins, and furans.

The company has acquired the assets of Fisher-Klosterman, Inc. (FKI), to further expand its access to the petrochemical, petroleum and power markets. FKI produces

cyclones, classifiers, electrostatic precipitator parts and service, air filtration equipment, and scrubbers.

The company's fiber bed filter technology is marketed under the CECO Filters trade name directly to customers. The principal functions of the filters are the removal of damaging mists and particles; the removal of pollutants; and the recovery of valuable materials for reuse. The filters are also used to collect fine insoluble particulates. Major users are chemical and electronics industries, manufacturers of vari

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Tangible resources

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity

Reputation

Organizational capabilities
