Chang Shan Hao Gold Mine

The company holds a 96.5% interest in the Chang Shan Hao Gold Mine, which consists of a licensed area of 36 square kilometers in the western part of Inner Mongolia, northern China, including an exploration permit of 25.91 square kilometers contiguously surrounding a mining permit of 10.09 square kilometers. It is centrally positioned within the east-west-trending Tian Shan Gold Belt. The site is approximately 650 kilometers northwest of Beijing.

Dadiangou Gold Project

The Dadiangou project consists of a licensed area of 15 square kilometers in Gansu Province, China. The project is located in the Qinling Fold Belt, a gold producing region that trends west to east through the provinces of Gansu and Shaanxi in central China. The company has an agreement to earn a 71% interest in the property. The company has completed a total of 14,910 meters drilled in 68 diamond drill holes on the property. The Dadiangou project hosts multiple gold-bearing shear zones up to 80 meters wide over a strike length estimated to be 4,000 meters.

Xinjiang Projects

The company holds 2 exploration permits covering 96 square kilometers in the Xinjiang Uygur Autonomous Region (Xinjiang) of Northwest China. The permits are held under a Chinese-Foreign Joint Venture in which the company holds a 99% interest and the partner, Yunnan Geological and Mining Co. Ltd., holds a 1% interest.

Strategic Alliances

In December 2009, Jinshan Gold Mines Inc. announced that it has entered into an agreement with Monnis International Inc. to jointly explore and develop gold projects in Mongolia. inshan and Monnis shall have 51% and 49% equity interest, respectively, in the acquired projects.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis
