China Precision Steel, Inc., a steel processing company, engages in the manufacture and sale of high precision cold-rolled steel products. The company's products are sold domestically in the People's Republic of China, as well as in overseas markets, such as Thailand, Nigeria, and Ethiopia.

The company conducts its operations principally in China through its wholly-owned operating subsidiaries, Shanghai Chengtong Precision Strip Company Limited and Shanghai Blessford Alloy Company Limited.

Products

The company produces and sells precision ultra-thin and high strength cold-rolled steel products with thicknesses ranging from 7.5 mm to 0.03 mm. It also provides heat treatment and cutting and slitting of cold-rolled steel strips not exceeding 7.5 mm thickness. The company's process puts hot-rolled de-scaled (pickled) steel coils through a cold-rolling mill, utilizing its patented systems and high technology reduction processing procedures, to make steel coils and sheets in customized thicknesses, according to customer specifications.

The company's precision steel products and services can be categorized into four major categories: low carbon steel (cold-rolled, hard-rolled) for use in steel roofing, food packaging, dry batteries, electronic devices, and kitchen tools; high carbon steel (cold-rolled and hot-rolled) for use in automobile parts and components, grinding pieces, saw blades, and weaving needles; steel processing; and steel services for heat treatment of hot-rolled steel coils; and cutting and slitting.

The company's cold-rolled sheet products are used in various end applications, such as appliances (refrigerators, washers, dryers, and other small appliances), automobiles (exposed as well as unexposed parts), steel roofing, food packaging materials, electric motors, microelectronics, and food packaging.

As of June 30, 2010, the company had an annual production capacity of approximately 185,000 tons, comprising one 1100 mm 12-high cold rolling mill, with an operating capacity of 100,000 tons; one 1400 mm 12-high cold rolling mill, with an operation capacity of 65,000 tons; and one 1450 mm 4-high cold rolling mill, with an operation capacity of 20,000 tons.

Suppliers

The company's major suppliers include Dachang Huizu Baosheng Steel Products Co., Ltd.; Guangzhou Zhujiang Steel Co., Ltd.; Wuxi Hangda Trading Co., Ltd.; and Jiangsu Sumeida International Technology Trading Co., Ltd. Its suppliers also include BaoSteel Steel Products Trading Co. Ltd; Shanghai Pinyun Steel Co., Limited; and Hangzhou Relian Company Limited.

Customers

The company's major customers include Shanghai Changshuo Steel Co., Ltd.; Shanghai Shengdejia Metal Co., Ltd; Hangzhou Cogeneration Co., Ltd.; Zhangjiagang Gangxing Innovative Construction Material Co., Ltd.; and Unimax and Far Corporation. Its customer also includes Salzgitter Mannesmann International GMBH.

Competition

The company's domestic competition in China's ultra-thin cold-rolled precision steel segment mainly comes from Qinghuangdao Longteng Precision Strip Co., Limited (Longteng). In the high carbon cold-rolled steel products segment, the company mainly competes with imports from Shinwha Steel Co., Ltd. in Korea.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
