**Harbin Tian Qing Biotech Application:** TDR organized Harbin Tian Qing Biotech Application Company as its wholly-owned subsidiary, to conduct research and development in the areas of tissue and stem cell banks.

Heilongjiang Tianlong Pharmaceutical: TDR acquired Heilongjiang Tianlong Pharmaceutical, Inc., which engages in the business of manufacturing external-use pharmaceuticals.

Heilongjiang Haina Pharmaceutical: TDR acquired Heilongjiang Haina Pharmaceutical Inc., which is licensed as a wholesaler of TCD, bio-medicines, bio-products, medicinal devices, antibiotics and chemical medicines.

Peng Lai Jin Chuang Pharmaceutical: TDR acquired Peng Lai Jin Chuang Pharmaceutical Company, which was organized to develop, manufacture and distribute pharmaceutical, medicinal and diagnostic products in China.

## Product Line

In 2009, the company manufactured and marketed 91 products. Its manufacturing operations are conducted in its indirect subsidiaries' facilities located in Heilongjiang Province and Shan Dong Province in China. It sells its products under five main categories, including Patches; Ointments; Sprays; Diagnostic Kit; and Others.

## Patch Category

**Sumei Slim Patch:** The Sumei Slim Patch is marketed and sold within and outside China as a more natural treatment to lose weight. The Sumei Slim Patch uses Saponin as its major ingredient, and is used in regulating and restraining the excessive secretion of certain hormones, and promoting others to foster weight loss, as well as prevent weight gain.

**Pain Relief Patch:** A pain relief patch is designed to apply to the area of neck, shoulder, and waist. The patch is used for a number of ailments, including fever, headache, heart dysentery, diarrhea, and stiffness and pain caused by hypertension.

**Anti-Hypertension Patch:** The product utilizes a Body-Yong-Guan point technique.

## Ointment Category

**Hemorrhoids Ointment:** This product contains Acetate, Radix Notoginseng, and Rhizoma Coptidis. It is made in soft ointment form that is used in sterilizing and relieving hemorrhoid symptoms, including itching, distending pain, burning, and bleeding.

**Compound Camphor Cream:** This product is made for the treatment of various pathogens on the skin surface and subcutaneously, such as mycete, trichopytic, staphylococcal bacteria aureus, bacillus coli, and candida albicans (thrush).

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
