About Cia Energetica de Minas Gerais

Companhia Energetica de Minas Gerais, through its subsidiaries, engages in the construction and operation of systems used in production, transformation, transmission, distribution and sale of electric energy, as well as the development activities in the different fields of energy.

Through subsidiaries, the company operates as an integrated concessionaire of electric power generation, transmission and distribution in Brazil. It operates generation, transmission and distribution businesses

pursuant to concession agreements with the Federal Government.

Segments

The company's main segments are its Generation and Transmission, and Distribution segments.

Generation and Transmission segment

Generation: As of December 31, 2009, the company generated electricity at 54 hydroelectric plants, 3 thermoelectric plants and 2 wind farm and had a total installed generation capacity of 6,442 MW of which hydroelectric plants accounted for 6,443 MW, thermoelectric plants accounted for 184 MW and its wind farm accounted for 15.11 MW.

Transmission: The company engages in the electric power transmission business, which consists of transporting electric power from the facilities where it is generated to the distribution networks for delivery to final users. The company transports energy produced at its own generation facilities as well as energy that the company purchases from Itaipu, the interconnected power system and other concessionaires. The company's transmission network consists of power transmission lines with a voltage capacity of approximately 230 kV and is part of the Brazilian Grid. As of December 31, 2009, its transmission network in Minas Gerais consisted of 1,352 miles of 500 kV lines, 1,244 miles of 345 kV lines and 485 miles of 230 kV lines, as well as 35 substations with a total of 94 transformers and an aggregate transformation capacity of 15,506 MVA.

Distribution segment

The company has a distribution concession in Minas Gerais that grants the company rights to supply electric energy to consumers within its concession area except for consumers that may be eligible, in accordance with the legislation, to become Free Consumers. The company's concession area covers approximately 219,103 square miles, or 96.7% of the territory of the state. As of December 31, 2009, the company owned and operated 294,552 miles of distribution lines, through which the company supplied electricity to approximately 6.8 million consumers.

Other Businesses

The company also engages in various businesses, including distributing natural gas in Minas Gerais through its consolidated subsidiary, Gasmig; telecommunications through its consolidated subsidiary Cemig Telecomunicacoes S.A., a company created to provide fiber-optics and coaxial cable network installed along its transmission and distribution lines through which telecommunication services can be provided; national and international consulting business through its subsidiary Efficientia S.A., whose focus is to provide its customers in the industrial, service and commercial sectors with energy solutions; and implementation and management of systems for electricity sector companies (generation, distribution and transmission) through its subsidiary Axxiom Solucoes Tecnologicas S.A.

Customers

The company's distribution and generation business consumers, who are located within its concession area in Minas Gerais and outside the state, are divided into five principal categories, including industrial (including mining, manufacturing, and processing activities); residential; commercial (including service-oriented businesses, universities, and hospitals); rural; and other (including governmental and public entities). As of December 31, 2009, the company sold 39,651 GWh of energy, which includes the energy sold by Cemig Distribution, Cemig Generation and Transmission and by affiliated companies.

The company's customers include Usinas Siderurgicas de Minas Gerais S.A.- USIMINAS (Cubatao - SP); Usinas Siderurgicas de Minas Gerais S.A.- USIMINAS (Ipatinga - MG); ArcelorMittal Brasil S.A.; ArcelorMittal Inox Brasil S.A.; Gerdau Acominas S.A.; Companhia Brasileira de Carbureto de Calcio –

CBBC; Ligas de Alumínio S.A.- LIASA; Italmagnesio Nordeste S.A.; Rima Industrial S.A.; and Companhia Ferroligas Minas Gerais – MINASLIGAS.

Significant Events

On November 10, 2010, Solaria Energia y Medio Ambiente has joined forces with Companhia Energetica de Minas Gerais, via the set-up of a joint venture for the building of a photovoltaic plant (PV) in Brazil. The new 3 MW plant is planned to be situated in Brazil's southeastern Minas Gerais state.

History
