Cinch Energy Corp. operates as an Alberta-based oil and natural gas company that engages in the exploration for, and the acquisition, development and production of, natural gas and crude oil, with emphasis on the deeper, western portion of the Western Canadian Sedimentary Basin in Alberta.

Properties

Chime, Alberta: The Chime property is located in northwestern Alberta, approximately 110 kilometers south of Grande Prairie. The initial interest in this property was acquired through a farm-in arrangement in late 2002. Production from this property in the six months ended June 30, 2004 averaged 1,038 Mcf/d and 17.4 Bbls/d of NGLs. The Chime property consists of 1,920 gross (740 net) acres of developed land and 61,760 gross (28,512 net) acres of undeveloped land and Cinch is the operator of most of these lands. During 2004, Cinch drilled one well (0.24 net) which was cased to 3,240 meters as a gas well.

Musreau, Alberta: The Musreau property is located in northwestern Alberta, approximately 10 kilometers north of the Chime property. Cinch has participated in the drilling of 2 gas wells (0.67 net) and in the re-completion of a zone for natural gas

production in another well. Production from this property averaged 114 Mcf/d of natural gas and 0.6 Bbls/d of NGLs in the six months ended June 30, 2004. Gross production in the month of July 2004 averaged approximately 700 Mcf/d natural gas and 4 Bbl/d NGLs. The Musreau property consists of 1,600 gross (441.6 net) acres of developed land and 6,080 gross (1,722 net) acres of undeveloped land.

Kakwa, Alberta: The Kakwa property is located in northwestern Alberta, approximately 100 kilometers south of Grande Prairie. Cinch's interest in the area was acquired pursuant to the Acquisition. The property is operated by Cinch. Cinch has interests in 4 gross (3.5 net) wells in the area from which production averaged 2,661 Mcf/d of natural gas and 157.8 Bbl/d of NGLs in the three months ended June 30, 2004. The Kakwa property consists of 2,560 gross (2,240 net) acres of developed land and 6,496 gross (6,176 net) acres of undeveloped land.

Bigstone/Fir/Resthaven, Alberta: The Bigstone property is in west central Alberta, approximately 30 kilometers southwest of Fox Creek. Cinch's interest was acquired pursuant to the Acquisition. The Bigstone/Fir area is located in an established exploration area for hydrocarbons. Cinch has interests in 3 gross (1.85 net) wells in the area from which production averaged 41.6 Bbls/d of NGLs and 1,054 Mcf/d of natural gas in the three months ended June 30, 2004. The Bigstone/Fir property consists of 3,200 gross (2,064 net) acres of developed land and 2,080 gross (1,340 net) acres of undeveloped land.

Wapiti/Bilbo, Alberta: The Wapiti property is located in northwestern Alberta, approximately 75 kilometers southwest of Grande Prairie. The initial interest in this area was acquired through a farm-in arrangement with a major oil and gas company. Cinch has an interest in one shut-in natural gas well (0.27 net) in this area which is awaiting pipeline connection. The Wapiti/Bilbo property consists of 640 gross (170 net) acres of developed land and 3,200 gross (3,200 net) acres of undeveloped land.

Ram River, Alberta: The Ram River property is located in Central Alberta, approximately 90 kilometers west of Red Deer. In 2002, Cinch participated in a 4,606 metre Elk Point test well which was dry and abandoned. Cinch has an interest in 17,120 gross (2,140 net) acres of undeveloped land in the area.

The Corporation's rights to explore, develop and exploit approximately 3,386 gross (597 net) acres of its undeveloped land holdings would expire by December 31, 2004, but plans to drill or submit application to continue selected portions of the above acreage.

History

Cinch Energy Corp. was incorporated pursuant to the ABCA in 1998 as 793935 Alberta, Ltd. In 2001, the Company changed its name to Cinch Energy Corp.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Tangible resources

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity

Reputation

Organizational capabilities
