The company has four coal projects in various stages of exploration, as well as Nimag Group (Nimag), its interim cash producing asset, which manufactures nickel magnesium alloys.

Mooiplaats Thermal Coal Project: The company holds 100% interest in Mooiplaats Thermal Coal Project in the Mpumalanga province. The Mooiplaats coal project is situated approximately two kilometers from the Camden power station near Ermelo in the Mpumalanga province of South Africa. An in-fil Drilling programme of approximately 37,000 meters was completed during 2007 taking the exploration meters drilled on the project to approximately 65,000 meters.

Makhado Coking Coal Project: The company owns a 100% interest in Makhado coal project located near Louis Trichardt in South Africa's Limpopo province.

Vele Coking Coal Project: The company holds a 74% interest in the Vele Coking Coal Project. Exploration on the Vele coal project west of Musina in the Limpopo province included a 65 hole geological programme, as well as a 31 large diameter cored hole programme.

Holfontein Coal Project: The company also holds a 100% interest in Holfontein Coal Project located in the Mpumalanga province.

Nimag Group (NiMag) (100%)

Nimag Group is engaged principally in the manufacture and distribution of nickel magnesium alloys, ferro silicon magnesium alloys, and metal fibres. It manufactures master alloys of nickel and magnesium for the specialized foundry industry, including aerospace, aeronautical, motor, steel mill roll and associated industries.

The company's operations also include Magberg Manufacturing (Pty), Ltd, a producer of ferro silicon magnesium alloys used to manufacture Ductile Iron; Metalloy Fibres (Pty), Ltd, a cast fibre reinforcing manufacturer in Africa; and Master Alloy Traders, Ltd, which trades various metals purchased from Nimag in South Africa.

Dispositions

The company disposed of its remaining investment in SA Mineral Resources Corporation Limited, which produces manganese sulphate chemicals.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
