#### Properties

##### East Texas/North Louisiana Region

The company owns interests in 923 producing wells (561.5 net) in 28 field areas. It operates 633 of these wells. The major of its fields in this region are the Logansport, Toledo Bend, Beckville, Waskom, Blocker, Mansfield, Hico-Knowles/Terryville, Darco, Douglass, Cadeville, and Longwood fields.

#### Logansport

The Logansport field located in DeSoto and Sabine Parishes, Louisiana primarily produces from the Haynesville shale formation at a depth of 11,100 to 11,500 feet and from multiple sands in the Cotton Valley and Hosston formations at an average depth of 8,000 feet. The company owns interests in 190 wells (119.9 net) and operates 133 of these wells in this field.

#### Toledo Bend

The Toledo Bend field is located in Desoto and Sabine Parishes, Louisiana. In 2009, it drilled 16 (10.1 net) Haynesville shale horizontal wells at Toledo Bend. The company owns interests in 15 producing wells (9.3 net) and operates 10 of these wells. As of December 31, 2009, the company had 3 wells (2.3 net) that were in the process of being drilled and 2 wells (1.8 net) in the process of being completed.

#### Beckville

The Beckville field is located in Panola and Rusk Counties, Texas. The company operates 193 wells in this field and owns interests in 78 additional wells for a total of 271 wells (162.4 net).

#### Waskom

The Waskom field is located in Harrison and Panola Counties in Texas. The company owns interests in 75 wells in this field (48.7 net) and operates 57 wells in this field. In 2009, the company drilled two horizontal Cotton Valley wells and one Haynesville shale well in the Waskom field.

#### Blocker

The company owns interests in 77 wells (71.3 net) and operates 72 of these wells. During 2009, it drilled three Haynesville shale horizontal wells and one Cotton Valley horizontal well at Blocker.

#### Mansfield

The Mansfield field is located in DeSoto Parish Louisiana. During 2009, it drilled 3 (1.9 net) Haynesville shale horizontal wells.

### Hico-Knowles/Terryville

The company owns interests in 71 wells (25.9 net) and operates 23 of these wells.

### Darco

The Darco field is located in Harrison County, Texas. The company owns interests in 24 wells (18.8 net) and operates all of these wells.

### Douglass

The Douglass field is located in Nacogdoches County, Texas. The company owns interests in 42 wells (26.9 net) and operates 34 of these wells.

### Cadeville

The company owns interests in 7 wells (4.0 net) and operates 5 of these wells.

### Longwood

The Longwood field is located in Harrison County, Texas. The company owns interests in 25 wells in this field (20.6 net), and operates 22 wells in this field. It drilled one Haynesville shale horizontal well in this field during 2009.

### South Texas Region

The company owns interests in 236 producing wells (125.6 net). It owns interests in 16 field areas in the region.

### Fandango

The company owns interests in 21 natural gas wells (21.0 net) in the Fandango field, located in Zapata County, Texas. It drilled two development wells in 2009.

### Double A Wells

The company owns interests in and operates 59 producing wells (28.6 net) in this field in Polk County, Texas.

## Rosita

The company owns interests in 32 natural gas wells (17.3 net) in the Rosita field, located in Duval County, Texas. It operates four of these wells.

## Las Hermanitas

The company owns interests in and operates 15 natural gas wells (12.2 net) in the Las Hermanitas field, located in Duval County, Texas.

## Javelina

The company owns interests in 17 natural gas wells and 1 oil well (18 net), in the Javelina field in Hidalgo County in South Texas.

## Ball Ranch

The Ball Ranch field is located in Kenedy County in South Texas. The company has interests in 34 producing wells (7.8 net) in this field. During 2009, it drilled 3 (1.4 net) wells in this field.

## Other Regions

The company operates in other regions, including Mississippi, New Mexico, Kentucky and the Mid-Continent regions. Within these regions, it owns interests in 482 producing wells (216.3 net) in 19 fields.

## Laurel

The Laurel field is located in Jones County, Mississippi near a structurally complex salt dome. The company owns interests in and operates 52 producing wells (49.1 net) in the Laurel field.

## San Juan

The company's San Juan Basin properties are located in the west-central portion of the basin in San Juan County, New Mexico. It owns interests in 97 wells (14.6 net) in this field.

## Maxie

The Maxie field is located along the southern boundary of the Mississippi Salt Basin and northern edge of Wiggins Arch in Forrest and Pearl River Counties in Mississippi. The company owns interests in and operates 3 wells (2.1 net) in this field.

## Customers

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

### Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

### **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
