The company focuses on the development of drugs based on its P2R- and NO-related technologies. It owns or has license rights to proposed drug candidates. The company focuses on the following diagnostic and therapeutic applications, which are in various active stages of development:

ATPace - A liquid formulation of ATP for intravenous administration, which the company is in the process of clinically developing as an antiarrhythmic drug for the acute termination of paroxysmal supraventricular tachycardia, as well as a new diagnostic test for identification of patients who faint due to an abnormally slow heart rate.

CDP-1050 - A once-a-day tablet formulation targeted at restoring the redox-NO balance in patients with chronic heart failure. The use of each of the two active ingredients of



this drug candidate alone is approved by the FDA. One of the ingredient suppresses the production of reactive oxygen species that damage myocardial cells and the other is an NO donor.

Vagonixen – The company's proposed drug that would be based upon proprietary P2 receptor technology for the treatment of chronic obstructive pulmonary disease (COPD) and chronic cough.

ATPotent – The company's proposed drug for the potential treatment of sperm of infertile males in conjunction with in vitro fertilization and intra-uterine insemination procedure.

Ocuprene – The company's proposed drug for the treatment of glaucoma.

#### Markets

The company develops and markets ATPace and ATPotent focusing on the U.S. market. With respect to Vagonixen and Ocuprene for the treatment of COPD and chronic cough and for glaucoma, respectively, and other potential product candidates, it focuses on the U.S. market, as well as certain foreign markets.

#### Strategic Alliances

The company has entered into strategic alliances and collaborative arrangements including those with Medtronic, Inc. and Cato Research Ltd.

## **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

## **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



## Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

## IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
