Chile Properties

In Chile, the company owns the Cerro Chacay Property, the Gloria Property and the Talca Belt Properties, has an option to acquire a 100% interest in the Andrea Property and a lease agreement for the Celeste Property.

Andrea Property: The Andrea Property is a gold prospect located 19 kilometres northwest of the city of Talca and 230 kilometres south of Santiago in the VII Region of central Chile and comprises 2 exploitation claims totalling 670 hectares.

Talca Belt Properties: The company has an Area Wide Option Agreement with Freeport-

McMoRan Exploration Corp (FMEC) for the exploration, and development of the Talca Belt Properties, which are located in central Chile. The Talca Belt Properties include 14 prospect areas, are 100% owned by Minera Cielo Azul Ltda (MCAL).

Cerro Chacay Property: The Cerro Chacay Property is located in Region III in Northern Chile, 50 kilo meters east of the town of Vallenar and 12 kilo meters south-east of the Relincho copper project owned by Teck Cominco Ltd.'s (Teck). The company controls the Cerro Chacay Property through MCAL's ownership of 10 exploration concessions totaling 2,900 hectares, 1,600 hectares of which are in the process of being converted to exploitation concessions.

Celeste Property: The Celeste Property is located 28 kilo meters to the south-west of the Barreal Seco Property and approximately 10 kilo meters south-west of the Salvadora Property and comprises a 2876 hectares claim block, contiguous with and along strike to the north-east from the Empresa Nacional de Minería owned Cerro Negro IOCG deposit.

Gloria Property: The Gloria Property is located in Region III in Northern Chile, 28 kilo meters south-east of the town of Copiapo, capital of Region III of Chile, 15 kilo meters east of the Candelaria Cu-Au mine, operated by FMEC, and 6 kilo meters east of the Punta del Cobre district.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
