New Brunswick Lands

McCully Field: The company owns various working interests in the McCully Field, located approximately 12 kilometers northeast of Sussex, New Brunswick. The company's interests in the McCully Field consist of four petroleum and natural gas leases: 100% working interest in ONG Lease (44,428 acres); 100% working interest in ONG Lease (40,930 acres); 50% working interest in ONG Lease (3,561 gross acres and 1780 net acres held jointly with PCS); and 50% working interest in ONG Lease (36,531 gross acres, 18,232 net acres).

Caledonia Field: The company's interests in the Caledonia Field consist of two

petroleum and natural gas leases: 100% working interest in ONG Lease (40,930 acres); and 50% working interest in ONG Lease.

Corridor / Crescent Point Lands

The company has a 50% ownership in three exploration leases located to the west of the McCully Field, covering an area of 106,740 gross acres (53,370 net acres).

Elgin Sub-Basin

The company has a 100% working interest in two exploration leases covering 118,146 gross acres in the Moncton basin in southeastern New Brunswick.

Havelock Area

The company holds a 100% working interest in ONG Lease (44,354 acres) located to the north of the McCully Field.

Gulf of St. Lawrence, Québec and Newfoundland and Labrador

The company holds Québec exploration licenses covering 123,550 gross acres (123,550 net acres) over most of the Old Harry prospect.

Anticosti Island, Québec

The company has interests varying from 50% to 100% in 1,700,293 gross acres (984,037 net acres) in approximately 30 exploration licenses covering lands across most of Anticosti Island. The company's 100% working interest exploration licenses cover part of the Jupiter fault prospect in the south-central part of the Island.

Prince Edward Island

The company has a 100% working interest in two exploration licenses covering 264,129 gross acres on Prince Edward Island.

Natural Gas Storage Licenses

The company holds a 100% interest in natural gas storage licenses (35,792 gross acres) located in Salt Springs in south-central New Brunswick, approximately 50

kilometers from Saint John.

Reserves

As of December 31, 2008, the company had proved natural gas reserves of approximately 77.5 billion standard cubic feet.

ANALYSIS FEATURES

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Intangible resources

Human

Innovation and Creativity

Reputation

Organizational capabilities
