Its preclinical projects comprise CB-01-16 for the prevention of opioid-induced constipation; CB-01-12 for protein delivery; and CB-01-14, an antibiotic. The company also engages in the manufacture of products for third parties. It has a strategic collaboration agreement with Santarus, Inc. Cosmo Pharmaceuticals S.p.A. is headquartered in Lainate, Italy.
