Crazy Woman Creek Bancorp Incorporated (the Company) is a Wyoming corporation organized in December 1995 at the direction of Buffalo Federal Savings Bank (the Bank) to acquire all of the capital stock that the Bank issued upon its conversion from the mutual to stock form of ownership on March 29, 1996. The Company is a unitary savings and loan holding company. The Company does not conduct any active business other than the investment in mutual funds.

The Bank attracts deposits from the general public and uses such deposits primarily to originate loans secured by first mortgages on one-to-four family residences in its market areas, consumer loans, commercial loans and loans secured by savings accounts. The principal sources of funds for the Bank's lending activities are deposits; the amortization, repayment, and maturity of loans; and Federal Home Loan Bank of Seattle (FHLB) advances. Principal sources of income are interest on loans, mortgage-backed securities and investment securities and the principal expense is interest paid on deposits and FHLB advances.

Lending Activities

The Bank's primary lending activity consists of the origination of one-to-four family

residential mortgage loans secured by property located in the Bank's primary market areas. The Bank also originates three and five-year balloon mortgage loans with 30, 20 and 15-year amortization periods.

Residential construction loans are made on one-to-four family residential properties to the individuals who will be the owners and/or occupants upon completion of construction. These loans are made on a short-term basis and permanent long-term financing is available to these borrowers.

The Bank also makes multi-family loans, including loans on apartment complexes located in the Bank's primary market areas. The Bank engages in lending on improved farm land with no dwelling, building lots and building acreage sites. The Bank also engages in loans for improved farm land with dwellings.

Deposits

Deposits are attracted principally from within the Bank's primary market areas through the offering of a selection of deposit instruments including regular savings accounts, money market accounts, NOW accounts, and term certificate accounts. The Bank also offers IRA accounts. Deposit account terms vary according to the minimum balance required, the time period the funds must remain on deposit, and the interest rate, among other factors.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity

Reputation

Organizational capabilities
