Operations

In August 2002, the Company acquired the construction division of Nihon Denken Co., Ltd. and established Shin-Nihon Denken Co., Ltd., (changed its name to Daito Trust & Building Co., Ltd.), a wholly owned subsidiary. The new subsidiary inaugurated its operations with the marketing of three new products that use the new external heat insulation construction method.

Shanghai Garden Plaza

Daito and its wholly owned subsidiary, Shanghai Daito Trust Construction Co., Ltd., have completed the final phase of construction of the Shanghai Garden Plaza, a luxury service apartment complex in Shanghai. This complex incorporates many facilities to support daily living on its large site. Its unparalleled services span the gamut from security countermeasures to educational facilities for children. Tenants are expected to come mainly from among the employees of the many foreign-owned companies that are establishing operations in the flourishing Shanghai region.

Shinagawa East One Tower

In March 2003, Daito completed construction of Shinagawa East One Tower, which is linked to the concourse leading to the new Shinkansen Terminal, opening October 2003. With three underground levels, 32 stories above ground and a total floor area of 119,000m2. It includes office space for lease and a hotel, and three floors are occupied by Daito's Head Office.

Day Service Centers for Seniors

The Company operates day service centers for seniors, assisting frailer seniors and those who require nursing care to maintain an autonomous lifestyle. The Company's first facility opened in June 1999 and the company's have five in operation. The business model involves Daito contracting with real-estate owners to build the facilities, which are then leased and operated by subsidiary Care Partner Co., Ltd. This offers landowners the opportunity for a more efficient utilization of real estate combining common rental apartments.

ANALYSIS FEATURES

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Tangible resources

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity



Reputation

Organizational capabilities
