## **About Daylight Energy Ltd**

Midnight Oil & Gas Ltd. (Midnight or the company) is a junior oil and gas exploration and production company based in Calgary and operating in the Western Canadian Sedimentary Basin. Midnight began its operations as a private company in 2000. Midnight focuses its activities in two high-potential areas; the Peace River Arch and the West Central area of Alberta. These areas are sweet gas areas that have multizone potential and allow year-round access. During 2002, Midnight established operating bases in both of these areas that include ownership and operatorship of facilities and infrastructure.

Peace River Arch

Deep Basin Area

The Peace River Arch area is located west of the town of Grande Prairie and includes the Deep Basin production area. In the Wapiti-Elmworth and Beaverlodge areas, Midnight targets the multizone gas potential within reservoirs of Cretaceous and Triassic age. In addition to the multizone potential, the area is characterized by numerous high-productivity large reserve gas pools.

The Wapiti-Elmworth area of Alberta is located approximately 15 miles west of Grande Prairie. Midnight has an average 60% working interest in 9,440 gross acres (5,680 net) of land. Primary targets within the Wapiti area are the reservoirs of Cretaceous age, which are part of the Deep Basin gas trap. During 2002, Midnight pursued a very active exploration and development drilling program, drilling seven gross (3.85 net) wells resulting in six gross (3.35 net) gas wells and 87% success rate.

The Beaverlodge area is located approximately 12 miles northwest of Midnight's Wapiti holdings. Midnight has an average 37% working interest in 5,760 acres (2,142 net) of land in this area. The property currently contains one gross (0.29 net) multizone gas well that came on production mid-March, 2003. The well is a high productivity well that was completed in the Halfway formation and production tested at rates of over 8.0 mmcf/d. The Halfway production is sour (approximately 8%) and has been tied into an offsetting sour pipeline and delivered into sour infrastructure. Midnight's partner is the operator of the current well and Midnight holds working interests varying from 15% to 100%. Midnight participated in a 30-square-mile 3D seismic program. For 2003, Midnight has a multiwell drilling program scheduled for this area.

The Rycroft and Sinclair areas are located near the town of Spirit River in northwestern Alberta. Additions to these areas were obtained from both the Foothills and Capture acquisitions. Following the acquisition of Capture, Midnight has an average 60% working interest in 6,400 gross acres (3,782 net) of land. Prospective targets in this multizone area include production of natural gas and oil from the Doe Creek, Dunvegan, Gething and Charlie Lake formations at depths of 950 – 1400 m. The properties are developed with a total of 16 (8.1 net) wells comprising interests in 10 gross (4.7 net) producing oil wells, and one (0.3 net) suspended oil well and interests in three gross (1.5 net) producing gas wells and two (1.6 net) suspended gas wells. Midnight also owns corresponding interests in a battery facility and associated flowlines. Following the acquisition of Foothills, Midnight initiated a program to increase allowable production from the area through a water injection scheme and constructed a pipeline to commence gas conservation.

## West Central Area

### Alberta

Midnight's key operating areas within West Central Alberta are Caroline-Ricinus, Garrington, Chigwell and Cardiff-Alexander. The Caroline-Ricinus area is located approximately 50 miles southwest of Red Deer, Alberta. With the addition of the

Capture lands, Midnight has an average 33% working interest in 12,818 gross acres (4,202 net) of land in this area. Midnight acquired over 60 square miles of 3D seismic coverage in the area. At Caroline the targeted formations are the Cardium and Viking conglomerates of Cretaceous age. Midnight's initial discovery was a major multizone gas discovery (0.3 net) well that was placed on stream in October 2002. In the winter of 2002/2003, Midnight operated the drilling of two wells.

The Garrington area is located approximately 40 miles southwest of Red Deer, Alberta. Midnight has increased its landholdings to 2,560 gross acres and has maintained its 100% working interest in this area. In 2002, Midnight conducted two drilling operations on these lands and a re-entry operation on a previously existing well resulting in two gross (2.0 net) gas wells and one gross (1.0 net) oil well. The gas wells tested at rates of 1.0 to 2.0 mmcf/d.

The Chigwell area is located 20 miles northwest of Red Deer, Alberta. Midnight has an average 36% interest in 19,200 gross acres (6,933 net) of land in Chigwell. Midnight has a varying interest in 10 gross (2.9 net) producing oil wells, four gross (0.3 net) producing gas wells and 10 gross (4.1 net) shutin gas wells.

The Cardiff-Alexander area is located approximately 35 miles west of Edmonton. The Cardiff-Alexander property offers multizone potential for natural gas production from the Belly River, Viking, Mannville and Devonian formations at depths of 800 – 1200 m. As a part of the Capture acquisition it includes a 55% ownership and operatorship in a 6 mmcf/d gas plant and associated gas gathering system which processes the majority of the production in the area. Midnight has an average 69% working interest in 28,480 gross acres (19,632 net) of land. This property has a total of 27 (15.6 net) wells consisting of 13 (6.5 net) producing gas wells, two (0.6 net) producing oil wells, 10 (7.7 net) suspended gas wells and one (0.5 net) suspended oil well.

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

## **VRIO Analysis**

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
