About Delta Natural Gas Co. Inc.

Delta Natural Gas Company, Inc. engages in the distribution of natural gas in the United States. The company's distribution and transportation systems are located in central and southeastern Kentucky. It owns and operates an underground storage field in southeastern Kentucky.

The company transports natural gas to industrial customers who purchase their gas in the open market. It also transports natural gas on behalf of local producers and customers not on its distribution system. It produces a small amount of natural gas from its southeastern Kentucky wells.

Segments

The company operates through two segments, a Regulated segment and a Nonregulated segment.

Regulated Operations

Distribution and Transportation: Through its Regulated segment, the company distributes natural gas to its retail customers in 23 rural counties. In addition, its



Regulated segment transports gas to industrial customers on its system who purchase gas in the open market. The Regulated segment also transports gas on behalf of local producers and other customers not on its distribution system.

The company's three service areas are Nicholasville, Corbin and Berea, Kentucky. In Nicholasville it serves approximately 8,000 customers, in Corbin it serves approximately 6,000 customers, and in Berea it serves approximately 4,000 customers.

Gas Supply: The company purchases its natural gas from a combination of interstate and Kentucky sources.

Interstate Gas Supply: The company has commodity requirements agreements with Atmos Energy Marketing (Atmos) for its Columbia Gas Transmission Corporation (Columbia Gas), Columbia Gulf Transmission Corporation (Columbia Gulf), Tennessee Gas Pipeline (Tennessee), and Texas eastern Transmission Corporation (Texas Eastern) supplied areas.

The Regulated segment purchases gas from M & B Gas Services, Inc. (M & B) for injection into its underground natural gas storage field and to supply a portion of its system.

Transportation of Interstate Gas Supply

The company's interstate natural gas supply is transported from market hubs, production fields and storage fields by Tennessee, Columbia Gas, Columbia Gulf, and Texas Eastern. As of June 30, 2010, Columbia Gas and Columbia Gulf transported for the company a total of 1,033,000 Mcf.

Kentucky Gas Supply: The company has an agreement with Chesapeake Appalachia LLC (Chesapeake) to purchase natural gas.

Gas in Storage

The company owns and operates an underground natural gas storage field that it uses to store a significant portion of its winter gas supply needs.

Non-Regulated Operations

Marketing and Production: The company operates its Non-regulated segment through



three wholly-owned subsidiaries. Two of these subsidiaries, Delta Resources, Inc. and Delgasco, Inc. and Delgasco, Inc. (Delgasco), purchases natural gas in the open market, including natural gas from Kentucky producers. It resells this gas to industrial customers on its distribution system and to others not on its system. The company's third subsidiary, Enpro, Inc., produces natural gas that is sold to Delgasco for resale in the open market.

Gas Supply: The company's Non-regulated segment purchases gas from M & B Gas Services, Inc. Additionally, its Non-regulated segment purchases natural gas from Atmos Energy Marketing.

History

Delta Natural Gas Company, Inc. was founded in 1949.

ANALYSIS FEATURES

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Tangible resources

Financial

Physical

Technological

Organizational

Intangible resources

Human

Innovation and Creativity



Reputation

Organizational capabilities
