The Container Shipping segment covers route networks based on lo-lo tonnage in the North Sea, the Irish Sea, and the north of Spain. This

segment serves international trading and haulage companies, producers of heavy industrial goods, and bulk- and tank-container operators. The Passenger Shipping segment operates passenger routes based on cruise-ferry tonnage in the North Sea and Kattegat/Skagerrak. This segment serves families, groups of friends, business travelers, companies, organizations, course organizers, tour operators, and agents and travel agents. The Terminal Services segment operates port terminals and processes unit loads, such as trailers, containers, automobiles, and industrial goods in Denmark, England, the Netherlands, and Norway. This segment serves freight and passenger-shipping companies, overseas car-shipping companies, and overseas break-bulk shipping companies. The Trailer Services segment operates trailer companies in Norway, Sweden, Denmark, Finland, Germany, Belgium, the Netherlands, the Great Britain, and Ireland that primarily services the market with transport solutions using DFDS' route network. This segment serves the importers and exporters of consumer goods; producers of heavy industrial goods, such as forestry products, chemicals, and plastics; and automobile industry and its sub-contractors. As of December 31, 2009 it operated a fleet of 51 ships. The company was founded in 1866 and is headquartered in Copenhagen, Denmark. DFDS A/S is a subsidiary of Vesterhavet Holding A/S.
