Gen-Probe's PCA3 Test: The company has a license and collaboration agreement with Gen-Probe to develop a urine based, nucleic acid test to detect the PCA3 marker for use as an aid in the diagnosis of prostate cancer. PROGENSA PCA3 is available across the European Union and a PCA3 based test is offered by five U.S. laboratories that are using PCA3 analyte specific reagents (ASR) manufactured by Gen Probe. The test is also available from two clinical laboratories in Canada.

Agreements

The company has a licensing and collaboration agreement with Gen-Probe, Inc. for the continued development of a test based on the PCA3 molecular marker and its commercialization.

History

DiagnoCure, Inc. was incorporated in 1994.
