33 Carats Property: The 33 Carats property is located along the Eastmain River in the Otish Mountains area, Quebec and covers 400 square kilometers in 5 blocks.

Hotish Uranium Property: The Hotish property is located near the lakes Magyar, Pepeshquasati et Mantouchiche in the Otish Mountains area, Quebec, and consists of 2 blocks covering 700 square kilometers.

Pontax Diamond Property: The company acquired, in a partnership with Sirios Resources Inc. (Sirios), the Pontax property. This property covers approximately 500 square kilometers in the James Bay area (PQ) 350 kilometers north of Matagami along the road to Radisson. Under the agreement with Sirios, each company holds a 50%



interest in the property.

Chibouki Diamond Property: The Chibouki project consists of 2 main blocks and covers 350 square kilometers. The diamantiferous project owned at 100% by the company is located near the town of Chibougamau, Quebec. These blocks are respectively located approximately 50 kilometers northeast and 40 kilometers north of Chibougamau, Quebec.

Opinaca Nord Uranium Property: The company has the right to earn a 50 % interest in this property. This property covers approximately 300 square kilometers in the James Bay area (PQ), 400 kilometers north of Matagami.

Upinor Uranium Property: The company jointly acquired with Sirios, the Upinor property covering approximately 451 square kilometers and is located 50 kilometers south of the Trans-Taiga road. Under the agreement with Sirios, each company holds a 50% interest in the property. The company manages this project. In 2008, the company completed a 12 holes drilling program, to test a 3 kilometers strike length along the extent of the Upinor outcropping five kilometers-long uranium A zone and in section.

U2 et U3: These properties cover close to 215 square kilometers in the James Bay area (PQ) 30 kilometers south of the Trans-Taiga road and of the La Grande-3 hydroelectrical reservoir.

Pam et Ugo: These properties cover approximately 255 square kilometers in the James Bay area (PQ) approximately 10 to 40 kilometers east of the Opinana nord property.

Lac Chabran Uranium Property: This property covers approximately 71 square kilometers in the James Bay area (PQ) approximately 10 to 40 kilometers east of the Opinana nord property.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Intangible resources Human

Innovation and Creativity

Organizational capabilities
