OK (Okeover) Property (Vancouver Mining Division): OK / Okeover is a copper-molybdenum project with

approximately 5,233 hectares in size and located on the coast near Powell River. The drill program in 2008 totaled approximately 1,448 metres in six holes.

Crowsnest Property, Fort Steele Mining Division, British Columbia: The company, in 2006, purchased 101 claims in the project area. This 2,282 hectare lode gold project is located in southeastern British Columbia approximately 10 kilometres southeast of the Howell Project.

Howell Property, Fort Steele Mining Division, British Columbia: The company has entered into an agreement to acquire a 100% interest in five mineral claims in the Fort Steele Mining Division, British Columbia. 12 holes totaling 1,312 metres of NQ core were completed in 2008, and two new soil grids were established.

Iron Lake Property, Clinton Mining Division, British Columbia: The company acquired 100% of the Iron Lake property from Canevex Resources Ltd. In 2008, a program of soil grid extensions was completed with 478 additional soil samples collected and analyzed.

Indata Property, Omineca Mining Division, British Columbia: The company has a 87.6% interest in the Indata property. The 2008 exploration program consisted of one drill hole in the porphyry copper target and four holes in the precious metal vein target.

Zymo Property, Omineca Mining Division, British Columbia: In 2007, the company entered into an agreement to acquire a 100% interest in the Zymo property. A total of 1,554.5 metres was drilled in six holes on the newly discovered Hobbes Zone.

Kilometre 26 Property, Omineca Mining Division, British Columbia: The company has staked mineral claims totaling 1,840 hectares located 55 kilometres northwest of Fort St. James, British Columbia.

Tonopah Project, Nevada: The company holds a 100% interest in 25 patented claims in the Tonopah district, Nevada, U.S.A.
