**Clearwater Project:** The Clearwater Project is located immediately north of the Eastmain River, 50 kilometers east of the Opinaca reservoir, approximately 320 kilometers north of the town of Matagami in the James Bay Region of Quebec. This property consists of claims totaling 199.4 square kilometers. These claims are held 100% by the company. In the period ended October 31, 2009, the company completed 68 HQ drill holes (ER08-177 to ER08-244) for a total of 21,276 meters to test the near-surface grade and continuity of the Eau Claire gold deposit.

**Eleonore South Property:** The Eleonore South project is located near the Opinaca Reservoir area of the James Bay Region, approximately 300 kilometers northeast of the town of Matagami, Quebec. The project consists of two separate blocks of claims comprising a total of 282 claims covering approximately 147 square kilometers. The Eleonore West block consists of 34 mineral claims covering approximately 17.8 square kilometers, while the Eleonore South Block contains 248 claims extending over an area

of approximately 129.8 square kilometers.

**Eastmain Mine Property:** The Eastmain Mine Project is located in the Upper Eastmain River Greenstone Belt, approximately 320 kilometers north-northeast of Chibougamau and approximately 800 kilometers north of Montreal, Quebec. The property consists of 152 mineral claims and 1 mining license covering approximately 8,014 hectares. The company owns 100% interest in the property.

**Reservoir Property:** The Reservoir project is located approximately 350 kilometers north of Matagami and approximately 750 kilometers north of Montreal, Quebec. The project is within the Eastmain/Opinaca region and encompasses a peninsula within the Opinaca Reservoir. The company owns 100% of 157 mineral claims comprising an area of 8,145 hectares.

**MegaTEM project:** The company and Xstrata Canada Corporation jointly search for base metal and gold deposits. The JV partners hold various claim blocks located within the Abitibi Greenstone belt in Ontario and Quebec. The company holds a 70% interest in any discovery made from these surveys.

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
