Permis de Recherché 5214 – Kasala: The project is located approximately 60 km north northwest of Lubumbashi. P.R. 5214 covers an area of 97.74 square kilometers.

Permis de Recherché 5215 – Munaka: The project is located approximately 50 km northwest of Lubumbashi. P.R. 5215 covers a surface area of 49.69 square kilometers.

Permis de Recherché 5216 – Musonge: The project is located approximately 40 km east-northeast of Lubumbashi. P.R. 5216 covers a surface area of 19.35 square kilometers.

Permis de Recherché 5217 – Kikus: The project is located approximately 50 km northwest of Lubumbashi. P.R. 5217 is the company's main exploration permit in the D.R.C. The project covers a surface area of 138.1 square kilometers.

Permis de Recherché 9316: The project is located approximately 5 km north of Lubumbashi. P.R. 9316 covers a surface area of 25.23 square kilometers.

## History

The company was founded in 1988. It was formerly known as Triple A Gold Mines, Ltd. and changed its name to Westwego Resources, Ltd. in 1989. Further, it changed its name to Corum Resource Corp. in 1995; and to El Nino Ventures, Inc. in 1999.

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
