### **About Ember Resources Inc.**

Ember Resources, Inc., a natural gas exploration and production company, focuses on extraction of coalbed methane (CBM) natural gas in the province of Alberta, Canada. The Company operates in three principal geographic areas of Alberta: Fenn/Big Valley located north-east of Calgary; Rosalind located south-east of Edmonton; and Manola located north-west of Edmonton. As of December 31, 2005 the Company held interests in 308,000 net acres of developed and undeveloped land.

The proved plus probable reserves are 15.7 Bcf; 1.6 Bcf is attributed to Ember's commercial Mannville wells at Rosalind with the balance booked for the Horseshoe Canyon project at Fenn-Big Valley.

#### **Mannville project**

The company's Mannville CBM project is located at Rosalind. As part of the demonstration phase, two horizontal wells (1.0 net) were drilled; one well is capable of producing at rates of 500 mcf/d the second well is producing 80 mcf/d. The company has nine CBM wells (4.5 net) producing from Mannville coals at a depth of approximately 1,000 metres.

## Fenn/Big Valley - Horseshoe Canyon coals

The company is operating a large CBM program at Fenn-Big Valley with an inventory of drilling locations. Drilling is targeting CBM production from shallow Horseshoe Canyon coals (150 to 350 metres). The company drilled 28 new Horseshoe Canyon wells (28 net).

## Manola - Mannville coals

The company's Manola property is in the demonstration phase with four vertical wells (4.0 net) producing from two Mannville coal seams. Six horizontal wells were drilled during 2005 at the company's demonstration project in Manola. The company's peers, Nexen and Trident, have announced commercial projects on nearby acreage.

## History

Ember Resources Inc. was incorporated in June 2005.

## ANALYSIS FEATURES

### SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

### Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

### PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

## Key Factors Examined by PESTEL Analysis:

**Political** – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

**Economic** – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

**Sociological** – What cultural and societal aspects will work upon the demand for the business's products and operations?

**Technological** – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

**Environmental** – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

**Legal** – What laws and legislation will exert influence on the style the business is carried out?

## **IFE, EFE, IE Matrices**

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

## **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?
