Enhanced Oil Resources, Inc. engages in the acquisition, exploration, and development of natural resource properties in the Southwestern United States.

Segments

The company has two segments Helium and CO2 resource segment and Crude oil and natural gas production segment.

Helium and CO2 resource segment

This segment engages in the exploration for and production of helium and carbon dioxide (CO2) within the St. Johns field (St. Johns Field), a 250,174 acre resource property in Arizona/New Mexico.

During 2008, the company drilled 15 net wells to various stages of completion in the St. Johns Field. This is in addition to the 13 net it drilled to various stages of completion during 2007. In July 2008, the company purchased a 100% working interest in a 1,900 acre New Mexico oil field.

Crude oil and natural gas production segment

This segment produces oil and gas from three Permian Basin crude oil fields located in eastern New Mexico. These fields represent only marginal production of approximately 200 barrels of oil per day (Bbl/d). The Milnesand Unit CO₂ pilot project (MSU Pilot) is its CO₂ pilot project, which commenced in March 2008, with CO₂ injection initiated in August 2008.

The Chaveroo field, which is comprised of approximately 350 wells within multiple unconsolidated operating units and other discrete operating leases, has approximately 60 wells capable of producing. Its Milnesand Unit is comprised of approximately 97 wells, of which 27 are capable of production.

Significant Events

On September 3, 2009, Enhanced Oil Resources Inc. announced a joint venture agreement with GreenFire Energy (GreenFire) to evaluate the potential for CO₂-based geothermal power production (CO₂G) from the St Johns Dome area, located in Apache County, Arizona and Catron County, New Mexico.

History

The company was founded in 1980. It was formerly known as Ridgeway Petroleum Corp. and changed its name to Enhanced Oil Resources, Inc. in 2007.

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

Enhanced SWOT is a 3x3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors

integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis
