EPAZZ BoxesOS v3.0

EPAZZ BoxesOS v3.0 (Web infrastructure operating system) is the company's principal product. EPAZZ BoxesOS integrates with each organization's back-end systems and provides a customizable personal information system for each stakeholder.

The company's services include single sign-on, which provides a single-sign-on with security procedure to product users' information and identity; course management system, manage distance, traditional courses, and calendar; enterprise Web site



content management, manage public sites with multi contributors; integration management services, integrated into enterprise resource planning (ERP) and mainframes; email management: email server and web client; instant messenger services, such as instant messaging and alerts; customer relationship management, such as prospective students and alumni; calendar/scheduler management, such as event directory, groupware, and personal calendar; administrative support services, such as online payment services; and business services, such as facility management and online bookstore.

Web Portal Component: BoxesOS Web portal component is a gateway to an organization's online services and information resources. The Web portal component provides personal information system, which refers to the user's online environment - the user's resources, information, graphics, color, layout, and organization. The Web portal component helps organization to create and deploy custom Web applications with a common graphic user interface and connectivity to the back-end systems.

Administrative Content Management: The company's content management component provides an organization with enterprise level tools for creation, management, organization, archiving, and sharing content. Content would be delivered in various forms, such as Web pages, emails, polls, documents, web forms, rich site summaries (RSS), and hot news. The content management component enables staff members to create Web pages and processes.

Work Hub: Work Hub helps to manage work flow in an organization. The applications in work hub include products/services management, project management, invoice management, time management, content management, and sales management.

Central Repository: Central knowledge repository is a collection and indexing of shareable content. Central knowledge repository installs a server index application on the Windows 2003 platform to identify an organization's knowledge assets. All knowledge assets are imported into a storage device. The server index application imports the knowledge assets into a temporary folder before moving into a main folder. The server index application prompts the organization's administrators to add detailed information about the knowledge assets into the database by using a Web form. These forms allow the administrators to add custom fields; allowing the organization to add custom information to the database in the present and at a future date. The organization would be able to group their knowledge objects by program, course, subject, topic, users, content, or date.



ViewPoint: ViewPoint is BoxesOS central communication hub, calendaring, contact management, and scheduling system. ViewPoint works with or is used as an alternative to MS Outlook/MS Exchange Server. The Web applications provide the institution with a range of options, including communication system email Web client and an email server. ViewPoint provides threaded discussion boards and a chatting environment. ViewPoint provides each user with a personal calendar, which notifies users of scheduling conflicts and appointments priorities. With the ViewP

SWOT Analysis

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

Enhanced SWOT Analysis

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

PESTEL Analysis

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.

Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

Porter Five Forces Analysis

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

VRIO Analysis

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:

Physical

Technological

Organizational

Intangible resources Human

Innovation and Creativity



Reputation

Organizational capabilities
