The company operates 49 International Business Exchange (IBX) centers, or IBX data centers, across 18 markets in North America, Europe and the Asia-Pacific where customers directly interconnect with a networked ecosystem of partners and customers.

#### Services

Equinix provides a choice of data center services primarily comprised of colocation, interconnection and managed IT infrastructure services.

#### Colocation Services

The company's IBX centers provide its customers with environments that are necessary for optimum Internet commerce interconnection. Its IBX centers include multiple layers of physical security, scalable cabinet space availability, on-site trained staff, dedicated areas for customer care and equipment staging, redundant AC/DC power systems and multiple other redundant and fault-tolerant infrastructure systems. The company also provides customized solutions for customers looking to package its IBX services as part of their complex solutions.



Cabinets: The company's customers have various choices for colocating their networking, server and storage equipment. In Europe, customers can purchase their own private 'suite', which is walled off from the rest of the data center.

Power: The company offers both AC and DC power circuits at various amperages and phases customized to a customer's individual power requirements.

IBXflex: IBXflex allows customers to deploy operations personnel and equipment on-site at its IBX centers. This space can also be used as a secure disaster recovery point for customers' business and operations personnel.

#### Interconnection Services

The company's interconnection services enable scalable, and interconnection and traffic exchange between Equinix customers. These interconnection services are either on a one-to-one basis with direct cross connects or one-to-many through one of its Equinix Exchange services. The company's staff holds significant positions in the industry groups, such as the North American Network Operators' Group, or NANOG, and the Internet Engineering Task Force, or IETF.

Physical Cross-Connect/Direct Interconnections: Customers needing to directly and privately connect to another IBX center customer can do so through single or multimode fiber.

Equinix Exchange: Customers may choose to connect to and peer through its Equinix Exchange via a central switching fabric rather than purchase a direct physical cross connection. The Exchange service is offered as a bundled service that includes a cabinet, power, cross connects and port charges.

Equinix IBXLink: Customers who are located in one IBX center may need to interconnect with networks or other customers located in an adjacent or nearby IBX center in the same metro area. IBXLink allows customers to interconnect between IBX centers at capacities up to an OC-192, or 10 gigabits per second level.

Internet Connectivity Services: This service, which is provided in its Asia-Pacific region, is targeted to customers who require a single bill and a single point of support for their entire services contract through Equinix for their bandwidth needs.



Carrier Ethernet Exchange Services: The company has announced the development of a new Carrier Ethernet Exchange service similar to the Equinix Exchange in four initial markets where customers would be able to connect via a central switching fabric to interconnect between multiple Carrier Ethernet Providers. The service would build on the benefits of the Internet community and extend the ability to interconnect the high growth Ethernet industry.

## Managed IT Infrastructure Services

Professional Services: The company's IBX centers are staffed with Internet and telecommunications specialists who are on-site and/or available 24 hours a day, 365 days a year. These professionals are trained to perform installations of customer equipment and cabling.

Smart Hands' Services: The company's customers are offered professional 'Smart Hands' service, which gives customers access to IBX staff for various tas

# **ANALYSIS FEATURES**

## **SWOT Analysis**

SWOT, which stands for Strengths, Weaknesses, Opportunities and Threats, is an analytical framework that identifies the internal and external factors that are favorable and unfavorable for a company.

## **Enhanced SWOT Analysis**

Enhanced SWOT is a 3×3 grid that arranges strengths, weaknesses, opportunities and threats into one scheme:

How to use the strengths to take advantage of the opportunities?

How to use the strengths to reduce likelihood and impact of the threats?

How to overcome the weaknesses that obstruct taking advantage of the opportunities?

How to overcome the weaknesses that can make the threats a reality?

Upon answering these questions a company can develop a project plan to improve its business performance.

#### **PESTEL Analysis**

PESTEL (also termed as PESTLE) is an ideal tool to strategically analyze what influence different outside factors – political, economic, sociocultural, technological, environmental and legal – exert on a business to later chart its long term targets.

Being part of the external analysis when carrying out a strategic assessment or performing a market study, PESTEL gives an overview of diverse macro-environmental factors that any company should thoughtfully consider. By perceiving these outside environments, businesses can maximally benefit from the opportunities while minimizing the threats to the organization.



# Key Factors Examined by PESTEL Analysis:

Political – What opportunities and pressures are brought by political bodies and what is the degree of public regulations' impact on the business?

Economic – What economic policies, trends and structures are expected to affect the organization, what is this influence's degree?

Sociological – What cultural and societal aspects will work upon the demand for the business's products and operations?

Technological – What impact do the technological aspects, innovations, incentives and barriers have on the organization?

Environmental – What environmental and ecological facets, both locally and farther afield, are likely to predetermine the business?

Legal – What laws and legislation will exert influence on the style the business is carried out?

## IFE, EFE, IE Matrices

The Internal Factor Evaluation matrix (IFE matrix) is a strategic management tool helping audit or evaluate major weaknesses and strengths in a business's functional areas. In addition, IFE matrix serves as a basis for identifying and assessing relationships amongst those areas. The IFE matrix is utilised in strategy formulation.

The External Factor Evaluation matrix (EFE matrix) is a tool of strategic management that is typically utilised to assess current market conditions. It is an ideal instrument for visualising and prioritising the threats and opportunities a firm is facing.

The essential difference between the above mentioned matrices lies in the type of factors incorporated in the model; whilst the latter is engaged in internal factors, the former deals exceptionally with external factors – those exposed to social, political, economic, legal, etc. external forces.

Being a continuation of the EFE matrix and IFE matrix models, the Internal External matrix (IE matrix) rests upon an investigation of external and internal business factors



integrated into one suggestive model.

# **Porter Five Forces Analysis**

The Porter's five forces analysis studies the industry of operation and helps the company find new sources of competitive advantage. The analysis surveys an industry through five major questions:

What composes a threat of substitute products and services?

Is there a threat of new competitors entering the market?

What is the intensity of competitive rivalry?

How big is the bargaining power of buyers?

How significant is the bargaining power of suppliers?

# **VRIO Analysis**

VRIO stands for Value, Rarity, Imitability, Organization. This analysis helps to evaluate all company's resources and capabilities and bring them together into one aggregate table that includes:
